The Miracle that Changed America’s Destiny

There is no question that America is now experiencing a political realignment where party coalitions are breaking up and new factions are emerging. Trump, who has sparked some of these shifts, has both benefited from and lost supporters because of this. On the international stage, the global order is collapsing, and most economies are in flux, likely for a while.

With all this change, we can expect increased political and economic volatility, both domestically and internationally. We can parallel the present day shifts to times like the 1930s or Reconstruction in the US. But know that the transitional interval will be no lackluster period ...as dramatically evidenced by the event on July 13.

But with all this said, it’s evident that a miracle took place on July 13. Heaven only knows what would have happened if Trump turned his head to the right 1/5 of a second later. From all accounts, by turning his head when he did to look at a chart on a Jumbotron screen, the bullet passed ¼ of an inch to the right of his head taking off a portion of his ear but not impacting his skull and mortally wounding him. Our country was 1/4 inch away from chaos.

In this report I will not get into great detail concerning the factors that led to the alleged shooter (20-year-old Thomas Crooks) trying to assassinate Trump nor all the theories now being bandied about (with much data supporting them) including multiple shooters being involved, and the almost unbelievable incompetence, if not complicity, of the Secret Service, the police and federal agents in an assassination plot to kill Trump.

It cannot be more stressed, in civilized societies violence like this directed against political figures no matter what party, Republican or Democrat, must not be tolerated. It would be just as horrendous if this had happened to Biden at a Democratic political rally. It shows America has indeed turned a dark and evil corner.

There are some that even say this incident was a staged "False Flag" event executed by Trump supporters to gain sympathy and support for him. But considering how close Trump came to actually being killed, it strains credulity to even ponder this was a faked event.

It's certain, in the aftermath there will be many investigations, theories and conclusions propounded about what happened on July 13. But, as in the JFK assassination case, it's uncertain if the truth of what really happened will ever be disclosed. But we need to realize that information released immediately after an incident is usually closer to being factual than that which is later released by the public media after being vetted by government agencies. This is a lesson we learned after the release of the JFK assassination, the Oklahoma City bombing and the 9/11 investigations. Here is a photo by Brandon Tatum, YouTube commentator and supporter of Trump, showing on that fateful day the positions of the shooter, Trump and the Secret Service agents who may have taken out the shooter.



As you can see, the shooter was about 130 to 140 yards from Trump and the rally crowd when he fired his rifle, barely missing Trump, killing one person and seriously injuring two others.

The following video still clips are taken from a video of a researcher who measured the time and direction of Trump's head as the bullet hit his ear but missed his head.

Researcher: "Pay really close attention to what's about to happen, because if Trump didn't turn his head here. He would no longer be alive."

“Now I want to show you this map from where the shooter is and you can see that by Trump actually turning toward the shooter to look at the chart, that saved his life.”



“I’ll show you what I mean. So, the shooter was aiming at his temple, OK. And the shooter is on the right side aiming here.”



“And as Trump turns his head, you can see right before the

bullet goes like this. See that?”



“So, it's like this. And then Trump turns his head. And it goes like this right past his ear.”

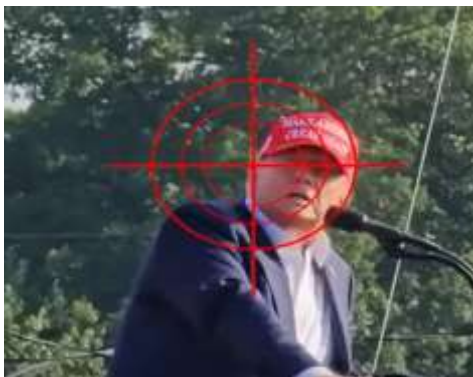

This is the image presented by the Wolves and Finance program showing the position of Trump’s head before he turns to look at the Jumbotron screen,



This is his position at the exact moment he is looking at the Jumbotron screen and the bullet flies past his head



“Now it gets even more interesting. The shooter was clearly seen on the roof for a full 5 minutes before he took the shot.”



“Now, if we watch exactly 18 seconds before the shot and start counting how many times Trump turns his head.” (there are 8 slides and every one shows the moment Trump turns his head to the right. This slide shows the third time he turned his head)



Trump speaking “And then the worst president in the history of our country, took over and look what happened to our country. Probably 20 million people and you know that’s a little bit old. That chart that charts a couple of months old and if you wanna really see something that said. Take a look at what happened.....”



“On the 8- time Trump turns his head to read the chart on the Jumbotron screen; the bullet goes by.”

Eight times Trump turned his head to the right. That’s about once every two seconds. So, the shooter was lining up the shot and by Trump turning to look at the chart the eighth time, it saved his life.”

So, maybe you can see how one can call this a miracle and a sovereign gracious act of God that can lead one to believe that God is using Trump for some grand purpose.

Further to this, I would like to point out that in March, four months before this assassination attempt occurred, Brandon Biggs, a pastor, prophesied in a videotaped interview that Trump would survive a bullet passing by his ear which would serve to bring Trump closer to God.



Here is the transcript of Brandon Biggs speaking in that videotaped interview in March 2024: “The Lord told me, I am not done with America, he said. All throughout, and I saw Trump rising

up. And then I saw an attempt on his life. That this bullet flew by his ear and it came so close to his head that it busted his drum eardrum and I saw he was, he fell to his knees during this time frame and he started worshipping the Lord. He got radically born again during this time frame. I'm talking, people say he is saved now, but he becomes really on fire for Jesus. For what I saw coming. And then I saw people interceding when he, and I see him, I saw him winning the Presidency through great. The Lord showed me it would go clear into the summer, great persecution would come on him, through the judges and through the law and all these people trying to sue him and all this stuff. But there would be a stop to it. And things would start to break free toward the fall.

The Biblical significance of blood on the right ear

The following passage is in the Bible and after I saw the blood dripping down Trump's right ear, I thought of this passage which became eerily prophetic to me (no pun intended).

In the Bible the concept of blood on the right ear (Leviticus 8:22-24 and 14:28) serves as a visible mark of consecration, signifying that the person is dedicated to God's service and has been set apart for a specific purpose. This act represents a physical and spiritual transformation, preparing the individual for their sacred role. Here's a breakdown of the significance:

***Right ear:** The right ear represents hearing and obedience. In ancient times, the right ear was considered the most important ear, as it was the ear that heard the words of God.

Unfortunately, this means we need to be prepared for increasing incidents of financial, technological and social disorder to come. I think these incidents have already begun when 6 days after the assassination attempt, on July 19 the largest IT outage in history occurred which shutdown airlines, financial services and hospitals that was reportedly caused by a defective software update by CrowdStrike, a major software company with servers in Ukraine.

It should be noted that CrowdStrike was founded by a Ukrainian named Alperovitch who early in the company's operations employed a person named Shawn Henry who previously ran the FBI Cyber Unit. CrowdStrike is also the same company that was involved in the 2016 Russian disinformation campaign against Donald Trump when he was running for election. The fact that this company and others like it are part of our communications infrastructure exposes a critical digital vulnerability in our central communications system. And it begs the question, could this have been an attempt by complicit agencies to shut down communication lines to prevent private investigatory agencies from finding vital information leading to the discovery of the real perpetrators who tried to kill Trump.

On the day JFK was assassinated in 1963, the CIA and NSA immediately shut down all communication facilities in Washington DC to prevent a tactical response by the US military against the agencies who killed Kennedy.

Another possibility is this IT shutdown was a beta test to see how effectively the perpetrators could shutdown mass communications systems to prevent forces to organize a counter-attack against them after they again try to eliminate Trump in the future. But these are just thoughts at this time.

In any case, it’s evident Trump faces great danger as he deals with this very uncertain future.

Other Issues in the Assassination Attempt

Here are several more unanswered questions dealing with the assassination attempt (taken from various programs including the *Jesse on Fire* YouTube program, the Legally Armed YouTube show, the Dark Horse show and the *Common Sense Show*)

These issues are being currently investigated and the findings may (or may not) be answered by subsequent investigation by the authorities.

The put option

Qui Bono (where the money goes) is a basic concept we learn in business school to employ when searching for the perpetrators of a financial crime.

Records show that on July 12 (the day before the assassination attempt) an investment firm named Austin Private Wealth LLC (APW) placed an order to purchase put options on 12 million shares of TMTG (Trump Media and Technology Group).

Right after the assassination attempt fails APW quickly withdraws the order citing a clerical error.



The APW order is suddenly gone

The size of this put options order could possibly be the single largest put option order ever made (which was allowed to be canceled based on a claim of a clerical error). The ability to cancel such an order in and of itself indicates the tremendous power and influence of the investors involved. If the company was not able to cancel the put option order when it did, it would have lost an enormous sum of money.

To be clear, a put option is an order betting that the price of a stock will go down. The more the stock goes down the more one makes on a highly leveraged basis. If the stock plummets, the investor can make a killing (no pun intended).

Could it be that APW placed the order because they thought TMTG stock would drop after July 12 giving them a huge profit? Why did they think the price of TMTG would drop after July 12? On 12 million shares of TMTG, the profit using put options would have been almost unbelievable. And if the stock went up after July 13, the company would have lost a huge amount of money. Incidentally, the stock went up.

For your information, contrary to a put option, a call option is a bet in the opposite direction, i.e. that a particular stock will go up. In options, if the investor is wrong in the direction the stock goes within a certain time frame, he could lose big time. So, when using options to invest in stock one needs to be right in the direction the stock price goes within a certain period of time.

Now, here is the kicker. The top investors in Austin Private Wealth LLC are reported to be the Rothchilds, Blackrock, Vanguard, Meta, George Bush and the Cheney Family.

On a side note, after the assassination attempt, I understand the news agencies had reported Mark Zuckerberg, head of Meta, said he is supporting Trump.

Evidence of Other Shooters

From the Water Tower

Besides Thomas Crooks shooting from the sloped roof building (called the American Glass Building) there is suspicion of another shooter on the top of the water tower, albeit experts have said the trajectory from the water tower to Trump is obstructed by a large screen and it would be a difficult shot from there without a brace.

In any case, here is a still frame of the video taken of the water tower right at the moment the shots are being heard in the video. There appears to be a dark figure standing on the top of the water tower at that very moment.



From the Dark Horse website, here is the photo of Trump pointing to the Jumbotron screen just before the shots begin.



If he is looking at the Jumbotron screen at the moment the shots are fired (shown by the red line), a shot from Crooks’s position (shown by the yellow line) would have hit Trump in the left temple.



We know the bullet hit Trump’s right ear. Behind the Jumbotron screen which Trump was looking at, is the water tower suggesting the bullet came from there. But the issue of a clear trajectory from the water tower is still in question.

From a window in the building behind Crooks

There is a theory that another shooter shot from the 2nd floor window (found open and unsecured) in a building located behind the building that Crooks shot from. Below is a photo from Legally Armed America showing the line of sight from this open window to Trump which closely aligns with the paths of the bullets fired by Crooks. The trajectory of the bullets from this second story open window which align very closely to the trajectory of Crook’s shots would best support the theory that there was a second very experienced marksman shooting Trump from this window that would cast the blame on Crooks as the patsy Lee Harvey Oswald style lone shooter .

him. It has been brought to the attention of authorities though recorded testimonies by the policemen present at the site, that they did NOT have communication with the Secret Service. This smacks of gross criminal negligence on the part of both the Secret Service and the local police unit. But if we consider that the Secret Service had ultimate authority over the security measures at the rally, a even more sinister conclusion could be reached that the Secret Service did not want to have communication with the local police on the scene. This leads to the question was the Secret Service complicit in a plot to expose Donald Trump to an assassination attempt on his life or worse, were they an integral part of a plan to assassinate him. It will be interesting to see what the final official investigation shows.

Police looking for man on roof minutes before Trump is shot

And here is a still photo from a video that surfaced on July 29, that was aired by the Jesse on Fire program.



The photo is taken seconds after Crooks is shot and the policemen are streaming out of the front of the same building that Crooks fired from. The 7-minute video was taken by a local resident of Butler PA visiting the rally who, after taking this video was arrested by a Pennsylvania State Trooper who handcuffed him, took his camera and then later released him along with his camera. The video shows the building and the roof which Crooks was lying on during the 3 minutes before the shooting began and 4 minutes thereafter. In the first 3 minutes the video shows several policemen running around the building looking at the roof trying to locate Crooks all the while Trump is heard talking in the background.

Also in the video you can hear the 8 shots presumably fired by Crooks, then a long interval of about 8 seconds and then a shot (or two) is heard at the end. Jesse on Fire said he believes the government sniper who took out Crooks fired this shot(s).

During the approximate 3 minutes the policemen were trying to find Crooks on the roof and assuming they had radio contact with the Secret Service, we have to wonder why didn't the Secret Service immediately stop Trump talking and cover

The sound recordings of the shots

In a YouTube video from Stephen Gardner YouTube program, there is a sound analysis of the shots conducted by Dr. Chris Martenson, a professional audio analyst, that reveals there were a total of 9 shots heard on various cameras located to the side of the building where Crooks was found. The first three shots were spaced 1/4 of a second apart followed by 5 very closely spaced shots and followed by a final single shot.

The first 3 shots were muffled, followed by the 5 shots that were staccato in sound, and the final shot was very different sounding like a slap. Martenson said Trump and the two other victims were injured by the first three shots which were pretty much on target. The unfortunate fireman was killed by one of the next 5 shots. But the different sounds and the timing between them strongly indicate that there were more than one single gunman involved. This leads to the suspicion that Thomas Crooks was merely a "patsy" like Lee Harvey Oswald to conceal the real shooter(s).



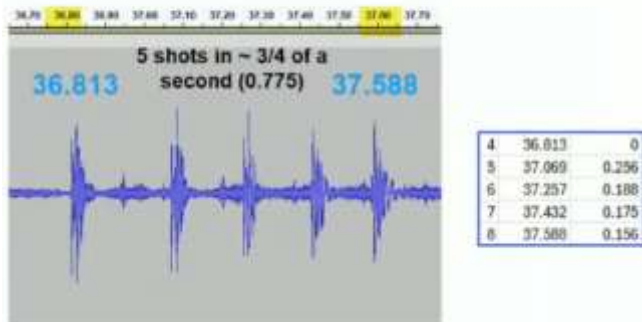

Incidentally, in the 5 shot burst, the split between the last four shots are at world record speeds and the bullets were all accurately close together. This would seem to indicate the shots were fired by a professional shooter.

It would seem a 20-year-old high school graduate who was reportedly unable to make his high school rifle team, would be hard pressed to fire his father’s AR-15 rifle in that fashion.

It should be noted that on July 25, the FBI Director Christopher Wray testified in Congress that Thomas Crooks fired 8 shots. Wray testified that there were 8 “cartridges” found on the roof near Crooks’ body. Technically, a cartridge is an unfired bullet so it’s unclear what Wray meant. Perhaps he meant 8 shell casings. In any case, with the first 3 shots having a very different sound signature from the next 5 shots and the last 5 shots being fired with professional time splits between them, it’s unclear how the FBI will explain this (of course this is assuming this sound analysis is allowed to be brought forth in an ensuing investigation).

As a side note, in collecting information for this article, I tried to locate a photo of the actual AR-15 style weapon that

Crooks used but I was only able to find this photo presumably of the rifle laying on the roof near Crooks’ body.



As a critical piece of evidence, it’s understandable a detailed close-up photo of the rifle would not be freely available. A rifle expert on Mrgunsngear Channel identified the rifle as having a Holosun red dot optical sight (barely discernable in the photo) which is a sight that does not provide any magnification. With a typical two-inch MOA (minute of angle) red dot placed directly on Trump’s head at 140 yards, it is very possible the wind would have made the bullet go two inches to the right missing Trump’s head.

On a side note, it would be interesting to see if the authorities confirm that the bullets they find are actual 223 caliber rounds used in an AR-15 type rifle and not the larger 308 caliber or 300 WinMag rounds used by snipers. Analysis shows that the size of the wound in Trump’s ear is consistent with what a 223 round would inflict.

Here is a photo taken from the program Legally Armed America. In the photo you see Crooks’ body and the rifle to its left.



Along with this photo there was shown a bodycam video of the investigating officers scouring the roof immediately after the shooting. In this body cam video, the officers are heard counting the shell casings found on the roof. Interestingly, in the beginning segment of this body cam video it shows the officers initially counting only a total of 5 casings. Then the body cam video timer mysteriously cuts off for a few minutes

and then resumes at a later time segment with the officers counting a total of “at least 8 casings.” The 8 casings are consistent with the testimony of FBI Director Christopher Wray who said there were 8 “cartridges” found on the roof.

The following article is also presented by Dr. Martenson who found it in the Gateway Pundit that appeared on July 22. It recounts the testimony of Greg Smith, who talked to news reporters right after the shooting occurred about him (Smith) seeing security agents on the second story of the building behind the building where Crooks was crouching just watching Crooks while the shooting was happening. Smith said he saw an agent with a tattooed forearm but he and the others did not do anything before or while the shooting was happening. Smith has not been interviewed by anyone after that initial interview. It would seem he should be on every news channel explaining what he saw. But according to commentator Stephen Gardner, who has contacted Mr. Smith, Mr. Smith now refuses to say anything further.

forearm. These agents may be part of the Butler Emergency Services Unit that were stationed on the second floor near the window that overlooks the roof where Crooks was on. It’s possible they are the ones who shot and killed Crooks.



Let’s Not Forget Greg Smith’s First Statements Right Afterward



Above is a photo of Crooks crawling around near the base of the American Glass building that Crooks climbed on top of. This photo of Crooks was taken by someone (probably one of the armed agents from the Butler Emergency Services Unit) from the second story of the building behind the American Glass Building. So, someone took this photo from the second story of the building behind the American Glass Building of Crooks crawling around the building well before Trump began talking and nothing was done to stop Crooks or prevent Trump from coming out onto the stage.

Holy Sh*t!

Expressively, he also relates that the snipers in the 2nd floor section of the AGR building were watching the rooftop shooter as the shots rang out – and did nothing!

“I was looking all around to get law enforcement’s attention before the shots, and I could tell it was coming, because as I was standing there for several minutes, I kept thinking ‘why is Trump still talking?’ You expect someone to be on the radio or whatever the protocol is, to get Trump off the stage. I knew this isn’t good. I expected the shots to start, and then they did. It was mass chaos. I was looking at the guys on the second story, my eyes were jumping three or four different places. I could see that they saw him and were looking at him and watching what he was doing, but they didn’t do anything.”

Butler County Sheriff’s Deputies have said that their body cameras were turned off and there is no footage available from the incident.

Another video (not audio) recording provided by consultant John Cullen alleges there were up to 10 shots fired with the 9th shot allegedly being 488 yards in distance and taking out the shooter on the water tower.

Cullen says the ninth shot by either the Secret Service or the police that took out the shooter on the water tower was made from the location indicated by the red star. However, this shot is yet to be confirmed.

Connections made by Crooks, the shooter

The following are taken from *Jessie on Fire* and the Dr Steve Turley program

An organization named the Oversight Project, a watchdog group with the Heritage Foundation, found the places where Crooks had visited the past year through an in-depth analysis of mobile ad data to track movements of Crooks and his associates. To do this they tracked devices such as mobile phones that regularly visited both Crook’s home and place of work and followed them.

They released findings that link Crooks to key locations inside the Washington DC area. Geo-tracking data shows that a phone associated with Crooks did indeed visit Butler Pennsylvania from his home in Bethel Park twice in the days just before the shooting. But what’s even more interesting and very suspicious is that the same cell phone last year visited the Gallery Place Building in Washington DC that houses a mall and a field office of the FBI.

The woman seated behind Trump

Regarding Diguisseppi, according to Dave Hodges of the *Common Sense Show*, Hodges found that she was involved in the FBI Jan 6 investigation and has worked as a private financial security consultant for the Cheney Family which is one of the investors in the Austin Private Wealth LLC, mentioned above, the company that tried to short 12 million shares of TMTG stock on July 12 and then abruptly pulled the put option order right after the assassination attempt, citing a clerical error that caused the order to be placed.

So, while Diguisseppi was not in the stands behind Trump she could possibly be involved in the financial transactions of Austin Private Wealth LLC (however the relevance of this is still uncertain)

What happened to the Director of the Secret Service

Finally, it's reported by sources that the director of the Secret Service herself, Kimberly Cheatle, is a close confidant of the Chaney family and the Carlyle Group who have substantial financial, and material interests that Trump opposes. Whether this is of relevance is yet to be proven (if it ever will be).



On July 22, Cheatle appeared before a congressional committee to answer questions about what happened at the political rally. It was one of the most scathing examinations of a government official ever with several congresspersons demanding her immediate resignation. Cheatle's answers were unusually evasive and several questions she coyly refused to answer. One of the questions was how many bullet casings were found near Crooks' body. Cheatle admitted she was told the number by the FBI but said it was still an ongoing investigation and so she could not answer that (later FBI Director Wray testified there were 8 cartridges found). Cheatle was also asked if there was another shooter. She refused to answer this. These types of refusals smack of a cover up of the assassination attempt going on within the Secret Service and other government agencies.

Just hours after the hearing Cheatle resigned as director of the Secret Services. Unfortunately, this deepens the suspicion that there is a cover up going on because now the message is being sent that with Cheatle's resignation, the investigation should be concluded, and everyone should move on. This begs the obvious question, was Cheatle the sacrificial lamb in a failed assassination plot?

As in the JFK assassination case, from here on the data will likely become increasingly difficult to find and secure. Thus, it will be up to the citizen journalists like those cited herein to locate and preserve the evidence if we ever hope to eventually know the truth.

A false flag is a political or military action carried out with the intention of blaming an opponent for it.

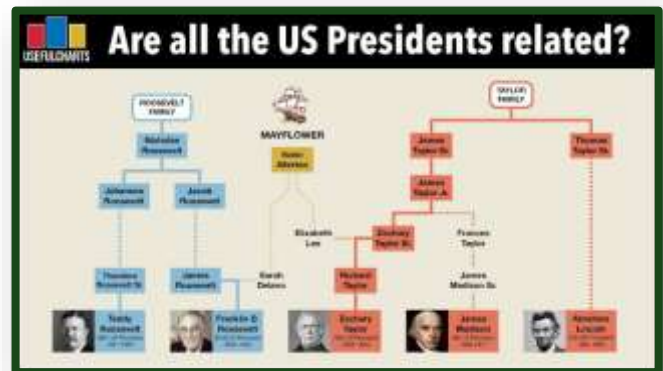
tary, the new Babylon. Call it what you will. But the day of reckoning is coming. And we're going to have hard choices to make. Believe nothing this administration says.

He is related to 20 British Dukes, the 13th cousin of Britain's Queen Mother, and of her daughter Queen Elizabeth. He is 13th cousin once removed from Prince Charles and has direct descent from King Henry III, Charles II, and Edward I of England. Through the House of Windsor and King Henry III, the Bush's and Bill Clinton are genetically related as well.

"According to Burke's Peerage, even according to the official genealogy, Bill Clinton is genetically related to the House of Windsor; the present royal family in Britain; to every Scottish monarch; to King Henry III of England; and to Robert I of France." -David Icke, "Alice in Wonderland and the World Trade Center"

In 2004 George W. Bush ran as a "Republican" against "Democrat" John Forbes Kerry - his 16th cousin. These cousins, related to the same British and French monarchs, are also secret society brothers in the infamous Skull and Bones fraternity. John Kerry descends from King Henry II of England and Richard the Lionheart, leader of the third Christian crusade in 1189. He also has links to royalty in Albania, Sweden, Norway, Denmark, Russia, Persia, and France, but still not enough royal genes to top George Bush. Earlier in 2000 we see the same story - George W. Bush ran neck and neck with Al Gore; another supposed democrat and cousin of the Bush family.

"Al Gore is a descendant of Edward I, Roman Emperors Louis I, II, and Charles II and is direct descendant of Charlemagne which makes him a distant cousin of Richard Nixon and George W. Bush. "Never in the history of the United States have two presidential candidates been as well endowed with royal alliances. There has always been a significant "royal factor," in those who aspired to the White House, with Presidents George Washington, Thomas Jefferson, Theodore Roosevelt, Franklin Roosevelt and Ronald Reagan, among others, all boasting blue blood links. Al Gore...a descendant of Edward I, he is also a cousin of former U.S. President Richard Nixon, who resigned from the White House in 1974 for his part in the Watergate scandal. However, Al Gore does have direct links to the Holy Roman Empire. He is descendant of Roman Emperors Louis II, Charles II, and Louis I and is therefore also a direct descendant of Charlemagne, the eighth-century Emperor. The problem is that Gore's Charlemagne links also make him a cousin of George W. By placing bloodline members on both sides of America's faux political dichotomy, the old monarchs have guaranteed their right to throne under the guise of democratic elections. Back in 1996 we see the same tactic as "Democrat" Bill Clinton defeated "Republican" Bob Dole, his cousin.

"Even Bill Clinton and Bob Dole, who 'opposed' each other at the 1996 election, are distant cousins. They can trace their an-

cestry to England's King Henry III, who reigned from 1227 to 1273, and US Presidents William Henry and Benjamin Harrison ...Clinton has far more royal blood than Dole and is directly descended from the same bloodline as the House of Windsor, every Scottish monarch, and King Robert I of France. This is why he was the Brotherhood's choice." -David Icke, "The Biggest Secret" (191-192)

The Windsor-Bush bloodline reaches from the American presidents, back to British/European royalty, and it doesn't stop there. It continues back through Roman emperors, all the way to Babylonian Kings and Egyptian Pharaohs near the beginning of recorded history.

From Marie Antoinette and King Louis XVI, the French line continues back through Louis XV-I, Charles XI-I, Henry IV-I, Philip V-I, Robert II and many other French monarchs. It passes the de Medici family, specifically Queen Catherine de Medici of France, who supported Columbus' expedition to the "New World" along with bloodline Queen Isabella of Castile, King Ferdinand of Spain, and the House of Lorraine. It was also Queen Isabella and King Ferdinand who started the 350 year Spanish Inquisition, which ordered the murder of millions who refused to convert to Christianity. And from the House of Lorraine, Duke Godfroi de Bouillon became the first Crusader King of Jerusalem.

"Father George and wife Barbara [Bush] are both descendants of Godfroi de Bouillon who, in 1099, led European noblemen in the successful Crusade to recapture Jerusalem from the Islamic faith and moved into the King's palace at Temple Mount ... Godfroi de Bouillon was the first king of Jerusalem and the Duke of Lower Lorraine, a major region for the Illuminati bloodline ...So when George W. Bush, a descendant of the de Bouillon through his mother and father, talked of a "Crusade" against "Islamic" terrorism...this was no slip of the tongue...as was reported" - David Icke "Alice In Wonderland and the World Trade Center Disaster"

The British line goes back from Prince William and Harry, through Prince Charles and Princess Diana, to Queen Elizabeth II, King George VI and V, King Edward VII, Queen Victoria, King Edward III, II, I, and King George III, II, I. Then it passes through King James I who ordered and financed the now most-widely read version of the Bible. Before James came Mary Stuart, King Henry III, II, I, King John (signer of the Magna Carta) and back to the Plantagenet and Habsburg dynasties under the Roman Empire. Other branches carried the bloodline to Scotland, Austria, Germany, Spain, Sweden and even Mexico:

"This same bloodline also includes key Scottish families like the Lords of Galloway and the Comyns; Marie-Louise of Austria, who married Napoleon Bonaparte; Kaiser Wilhelm II, the king of Germany at the time of the First World War; and Maximilian, the Habsburg emperor of Mexico, who died in 1867. On and on it goes into country after country. This bloodline connects into every surviving royal family in Europe, including King Juan Carlos of Spain and the Dutch, Swedish, and Danish royal lines." - David Icke, "The Windsor-Bush Bloodline"

The Most Important Rule for Income Investing

Before the Habsburgs, the House of Lorraine and Charlemagne were the Merovingians (Meroveus/Merovee) who originally brought the bloodline to France and Northwest Europe. Back in 4th century Rome the bloodline passed through Emperor Constantine, the first professed Christian emperor who initiated the Roman Empire's transition into a Christian State and presided over the first Council of Nicaea. He was preceded by the Roman Piso family whom will be discussed at length later. Before them came Herod the Great of Biblical fame and Ptolemy XIV, son of the most well-known Roman Julius Caesar. Caesar actually married into the bloodline through Cleopatra, the most well-known Egyptian Queen. A little further down this very same bloodline brings us to Alexander the Great:

Back the bloodline goes past Alexander, past Nebuchadnezzar IV, III and other Kings of Babylon, all the way to ancient African Kings and Pharaohs of Egypt - Ramesis II, I, Tuthmosis IV, III, II, I, Amenhotep III, II, I and many more. For millennia these Kings, Queens, Pharaohs, and Emperors have obsessively interbred with themselves to preserve and spread their bloodline. Income investing intimidates some investors...

But it shouldn't.

Despite what folks think, income investing is actually *easier* than picking growth stocks or trading options, once you know how to do it... due to the stability and long-term focus of income investments.

I worked on Wall Street for a decade helping investors manage risk. I was on one of the elite trading desks at Goldman Sachs. After that, I went to medical school and became a board-eligible eye surgeon. All the while, I've been semi-retired and using my savings to produce income to live and invest.

But in 2008, I launched my first newsletter with Stansberry Research, which let me share my investing ideas and help my readers live a healthy and wealthy retirement.

That's because I love helping readers of various backgrounds generate wealth and be healthy. Learning finance and medicine from the inside showed me how easily I could help empower people.

During the past few years, I've figured out what keeps people from proper income investing. It requires initiative and effort to take control of your financial future.

But even once you understand that, investors – and income investors in particular – still tend to get sidetracked.

Most new investors learn the basics of how stocks work. For income investing, that's not enough...

To be a complete income investor, you can't limit yourself to just dividend-paying stocks. You need to diversify your portfolio with bonds, real estate investment trusts, master limited partnerships, exchange-traded funds, annuities, and certificates of deposit, to name a few.

But no matter what you're buying, if there's one thing income investors should constantly remember, it's to buy value. By that, I mean you should always pay a fair price for what something is worth.

It seems simple... But it's the first thing investors forget. The latest hot stock tip or brand-new technology story can quickly push a stock's valuation into the atmosphere.

Value investing is one of the greatest investing strategies of all time. The father of modern investing analysis, Benjamin Graham, first published his book *Security Analysis* in 1934. The book discussed buying stocks with low price-to-earnings (P/E) ratios and low price-to-book (P/B) ratios. Graham's ideas have been tested and proven to be profitable by dozens of academic studies. They even helped to make superinvestor Warren Buffett his fortune.

In 1949, Graham published *The Intelligent Investor*. In it, he explained why you should only buy stocks when their P/E ratios are less than 15 and their P/B ratios are less than 1.5. That strategy has also been proven successful over the years.

But I don't subscribe to any hard-and-fast rule. P/E ratios don't always apply to exactly what we're investing in. And markets change... so we can't count on one single number for the rest of time.

The one rule you should follow for every investment you make is to write down a compelling argument for why it's undervalued. Maybe the stock is cheaper than its competitors... or the market as a whole. Maybe it has a better product than its competitors. But whatever your reasoning is, you should force yourself to do this exercise every time. That will keep you away from investing in popular, overvalued stocks.

If you've ever thought of becoming an income investor, now is the time to start.

My team and I believe we are approaching a new enlightenment for income investors. Yields are up across the board.

History “Facts” That Aren’t True



One of my favorite slogans is “Those who fail to learn from history are doomed to repeat it.” But what about those (including me) who think they’re learning history but are actually reading myths? It’s evident that a number of well-known historical anecdotes are either exaggerated or completely false, making the task of discerning fact from fiction all the more difficult. From apocrypha to popular misconceptions, here are six historical “facts” that aren’t true as reported by *History Facts*.

Myth: People Were Burned at the Stake During the Salem Witch Trials

Though 20 different people were indeed convicted of witchcraft during the infamous Salem hearings of 1692 to 1693, none of them were burned at the stake. Nineteen of them — 14 women and five men — were hanged, five died in jail, and one man was pressed to death with stones after refusing to enter a plea. The confusion stems from the fact that those found guilty of witchcraft in Europe (where it was treated as heresy) were burned at the stake. “Burning was supposedly a way to purify the convict, and also as a threat to uncover conspiracies,” according to *The Salem Witchcraft Trials: A Legal History* author Peter Hoffer. Hanging them, meanwhile, was punitive.

Myth: Cleopatra Was Egyptian

Though she ruled over Egypt as its last pharaoh and was born in the ancient kingdom, Cleopatra wasn’t ethnically Egyptian. As part of the Ptolemaic dynasty, she was actually a Macedonian Greek believed to have descended from one of Alexander the Great’s generals. Her name came from the ancient Greek *Kleopátra* (Κλεοπάτρα), meaning “honor of the father” or “glory of her father.” She was, however, the first of her line to learn the Egyptian language and is known to have made other efforts to embrace her subjects’ customs.

Myth: Marie Antoinette Said “Let Them Eat Cake”

It’s gone down in history as one of the most out-of-touch quotes of all time — one that emblemized the last queen of France’s disregard for her own people. There’s just one problem: Marie Antoinette never said it. The actual words in question, “qu’ils mangent de la brioche,” come from Jean-Jacques Rousseau’s autobiographical book *Confessions*, in which he wrote: “At length I remembered the last resort of a great princess who, when told that the peasants had no bread, replied: ‘Then let them eat brioches.’” That passage was written in 1765, at which time Marie Antoinette was still a child and had yet to step foot in the country she helped rule from 1774 until the French monarchy was abolished in 1792, a year before her execution. After accidentally stepping on the executioner’s foot, she spoke her last words, which were considerably more polite than the quote so often attributed to her: “Pardon me, sir, I did not do it on purpose.”

Myth: Napoleon Was Short

Despite having a certain complex named after him, Napoleon Bonaparte was of average height for his time. Part of the confusion stems from the nickname “Le Petit Caporal,” which makes him sound “little” but was actually a term of endearment among his troops. There’s also the fact that inches were measured differently in 19th-century France than they are today. The former was equivalent to 2.71 centimeters, whereas the current measurement is 2.35 centimeters, which explains why he was only considered 5 feet, 2 inches tall when he died. Most estimates put him closer to 5 feet, 6 inches or 5 feet, 7 inches — not exactly a towering figure, but average or slightly above average by 18th-century standards.

Myth: The Library of Alexandria Burned Down in a Fire

Few symbols of knowledge loom as large in the collective imagination as the ancient Library of Alexandria, whose supposed burning has long been recognized as a monumental loss civilization has never fully recovered from. And while it's true that the famed institution eventually ceased to exist, it wasn't destroyed in a single conflagration that took much of the world's ancient wisdom with it. What actually occurred is less dramatic but, in its own way, just as tragic: Both the collection and its influence slowly dwindled over the course of several centuries until whatever was left to burn represented a tiny fraction of the hundreds of thousands of papyrus scrolls once stored there.

No one is sure exactly what happened to the library — which was in fact part of a larger institution devoted to the Muses (goddesses who inspired all arts and knowledge in ancient Greece) known as the Mouseion — though everyone from Julius Caesar to Theophilus I of Alexandria has been blamed for its destruction. The library may be no more, but its legacy persists.

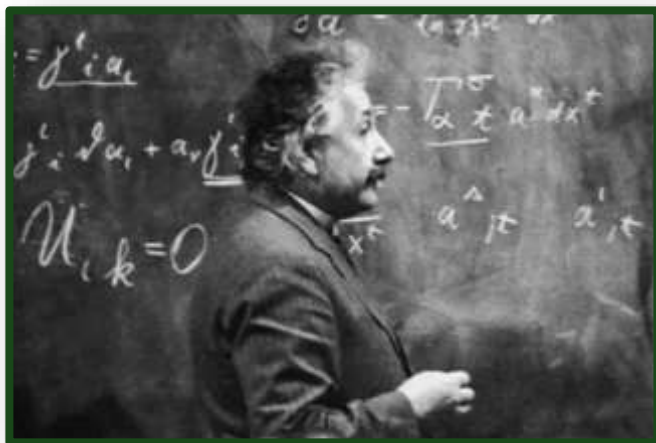

Myth: Albert Einstein Failed Math

Though it's often cited as evidence of his humble beginnings, Einstein didn't actually fail math. “I never failed in mathematics,” Einstein said in 1935 when presented with a Ripley's Believe It or Not! headline

In human history, we have had several great civilizations emerging and lasting thousands of years making an impact that has had severe impacts on generations to come. Advanced human civilizations have existed for more than 10,000 years. The first known complex civilization started in the fourth Millennium BCE in Sumer Mesopotamia. Since then, many great empires have come and gone, leaving behind their great legacies, artifacts, architecture, monuments, inventions and innovations. On some occasions civilizations fell apart in hours, like Pompeii or through several years of economic crisis. The collapse of these past empires was due to four major factors, political issues, social and cultural issues, environmental issues and economic issues. Economic issues can be considered the key reason for the sudden fall of these civilizations. It made scientists curious, and they started working to predict the collapse of modern civi-

lization.

In 1972, a team of researchers studied the risks of a doomsday scenario examining the restricted availability of natural resources and the rising costs that would subvert the possibility of economic growth in the second decade of the 21st century.

Here are the findings of those scientists as presented in a report by *Wealth Professor* entitled *MIT's Terrifying Prediction: "Society Will Collapse in 2040"*

I am not saying their dire findings will come true, but the credentials of the scientists making these findings compel us to seriously consider the serious ramifications of their findings.

Considering the assassination attempt on Trump's life (that will likely lead to his reelection in 2024), and the independent predictions of economists who say, despite who becomes president, there will be a big financial crash following that, the predictions of the MIT researchers have eerie implications.

MIT Scientists in the 1970s designed a computer model to predict the collapse of a society.

In 1972, a team of researchers at the Massachusetts Institute of Technology (MIT) widely regarded as one of the world's leading institutions,

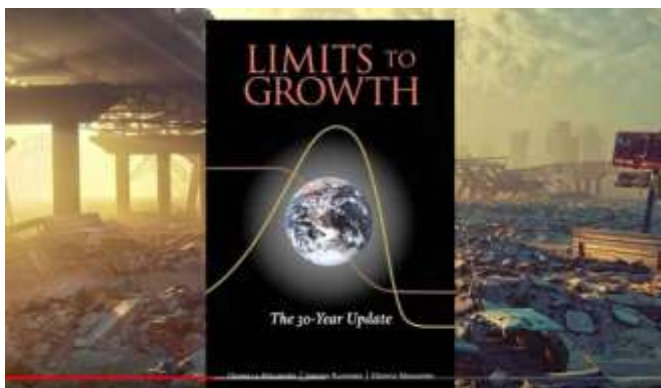


predicted that rapid economic growth would lead to a societal collapse in the middle of the 21st century. They created a method based on the computers sporting dynamic systematic model that was dubbed, World 1.

It was one of the first economic studies ever to use a computer program for looking at a timeline from the year 1900 to 2060. This data was produced on sheets of data in the form of graph lines. They analyzed the data from a range of factors and generated future scenarios with variables like population, energy usage, food, industrialization, use of non-renewable natural resources and pollution which included carbon emissions. It's worth noting that this study was done in 1972 before climate change was more than a blip on the scientific communities radar. The research the MIT scientists undertook was published in a book named Limits to Growth.

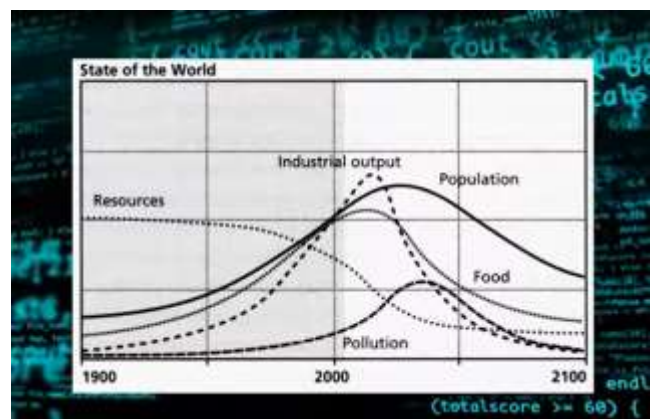


The test results, published in 1972 in Limits to Growth were no laughing matter. The MIT team discovered that a so-called “business as usual” approach

to economic growth



would drain the planets resources and lead to a collapse within the 21st century. While humans and civilization would not end, people would be rather worse off than previous generations stuck with tumbling food production, industrial output and population numbers. The prediction concluded with the idea that societal collapse would occur near the midpoint of the 21st century



which happens to be the year 2040.

The book mentioned how our industrial civilization is doomed if governments and companies keep extracting resources for further economic growth. It also presented 12 parallel futures with nearly all of them ending up with resource scarcity that results in a huge drop in quality of life.



But not all future scenarios in Limits to Growth we're so bleak. The MIT team also discovered that a stabilized world was possible if society reconfigured priorities around the well-being of citizens, use resources efficiently and cut pollution. While the book went on to sell 30 million copies and was published in 30 languages, the initial response was mixed. Some considered it as a foreseeing warning on the dangers of endless consumption and the gleeful ravaging of the natural world. Others were heavily critical of the research.

As the world looks forward to a rebound in economic growth following the devastation wrought by the pan-

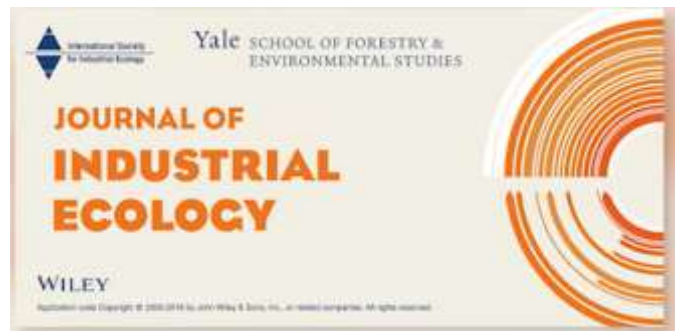
demic, the research raises urgent questions about the risks of attempting to simply return to the pre pandemic normal.

A remarkable new study by a director at one of the largest accounting firms in the world KPMG, has found that a famous decades old warning from MIT about the risk of industrial civilization collapsing might be valid based on new empirical data.

At the same time, a new study was authored by a Dutch researcher. Gaya Herrington, a sustainability and dynamic system analysis lead at the U.S. KPMG firm.



Published in the Yale Journal of Industrial Ecology in November 2020,

around the time when the pandemic hit, the study highlighted how the “business as usual” trajectory across the globe declined as the economic growth slumped due to the pandemic, comparing it with the MIT predictions.

The current data aligns with the predictions made back in 1972 that had a worst-case scenario of economic growth coming to a halt at the end of this decade and collapsing around 10 years later.

Harrington emphasized 10 variables such as fertility rates, mortality rates, human welfare, population, ecological footprint, non-renewable resources, food production services, pollution and industrial output. She discovered that our mentality emphasizing business will result in an economic growth fall within the next decade followed by a total societal collapse by 2040.



A total societal collapse would mean an abrupt decline in quality of life, food production, industrial output and ultimately the human population. In her estimates, the 2100s will be comparable to the 1900s. However, she is treating her research as a personal project, as a precaution to see how well the MIT model holds up.

Harrington discovered that the latest data shows striking similarities with the two scenarios of BAU “business as usual” and CT “comprehensive technology”. Both scenarios thus indicate the continuing “business as usual”, that is, pursuing continuous growth is not possible. Even when paired with unprecedented technological development and adoption business as usual as modeled by Limits of Growth, the MIT book, based on its study, would certainly lead to declines in industrial capital, agricultural output and welfare levels within this century.

Herrington underscored that although the MIT World 3 model shows societal impact from the economic and industrial growth, it is not meant to scare people and does not translate to the extinction of humanity. Harrington clarified that a collapse does not mean that humanity will cease to exist. But it will destroy our way of life, she added saying that economic and industrial growth will stop and then decline which will hurt food production and standards of living.



Even though the 1972 simulation suggests that our society will be doomed in the future, Herrington's

study reveals that technological improvement,



as

well as additional investment in public services could steer us away from the predicted total collapse from which nothing can save the human race. In a sense, Herrington emphasizes that humanity will have to make strong efforts in the coming decade to change the societal collapse prediction to have any chance of reversing the impact of wanton economic growth at the loss of environment and ecology.

What are your thoughts about these predictions?
