We've known for a long time that our nation has split in two...But now, it appears we could be on the verge of literally "breaking up"... in what some describe as a new kind of "Civil War."

On the surface, this sounds impossible but look at what's happening...As the Wall Street Journal reported in mid-November: "Across Illinois, California, Idaho, and other states... residents are pushing to break off and form new states." Then there's Texas, where Newsweek reports the state just elected 10 new legislators who've pledged support for a referendum to leave the United States.

Eifrig: Today, Porter will reveal all. He will detail what may be the most serious warning he's ever issued in his 30-year career and covered an investment idea he's never shared here before. In fact, it's something we've never covered in our 25-year history. Porter, it's great to see you.

Stansberry: Well, thank you for that very kind production, Doc. It's very nice to be here with you.

Eifrig: To fill everyone in over the past few days, Porter and I have been wondering what's next for America and the markets and we've come together today because what's going on in this country right now is well, frankly, quite disturbing. Porter. Lots of people are talking about how divided our country is. In fact, a Pew Research study found that America was more split than any other nation on political, racial and ethnic lines. But what you're saying is really way beyond any of that. You're saying what's coming next is much worse than battles over taxes or tariffs. It's worse than a market crash or the inevitable attempts at impeaching Trump again. What you're predicting now is, in your words, America's next civil war. OK, I'm. I'm sure many folks at home are shaking their heads thinking really. Is Porter serious, a civil war?

Stansberry: Yeah. So, Doc, let me say this as definitively and simply as I possibly can. I am deadly serious and I mean exactly what I'm going to say. We are going to have a civil war in this country. If you study economic history, you know that democracies can only exist while the voters figure out that they can vote themselves other people's money. And that's exactly where we are right now on the long descent in our country. And look, Doc, we're not going to have uniformed armies fighting on pitched battlefields. No one's going to take on the US military. It's not going to be, you know, the Marines. That's not how civil wars are fought anymore. But make no mistake, there will be fighting and violence. And there will be two very distinct sides. But it won't necessarily be the Democrats against the Republicans or one state against another state. But when I show you these numbers, when I show you these facts and when you see what's happening, I know you're gonna come to the same conclusion that I have. Which is that another civil war in America is not only probable, it's inevitable. And it's gonna start a lot sooner than anybody realizes. We're talking about in the next several months. The Democrats control the House and the Senate for roughly 6 more weeks. And the fact is, people are already advocating radical new laws to strictly limit Trump's power. Doc, a former Obama administration official, wrote the day after the election "Congress needs to treat the next two months as if a fascist is taking over to fundamentally change America. We have levers of power we need to use them. This cannot be business as usual."

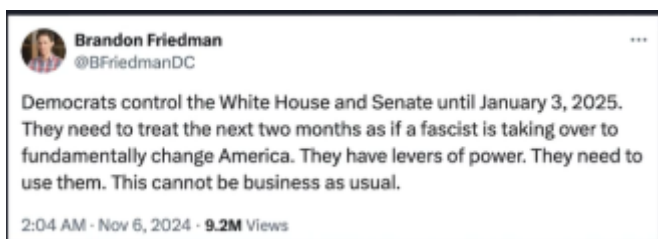
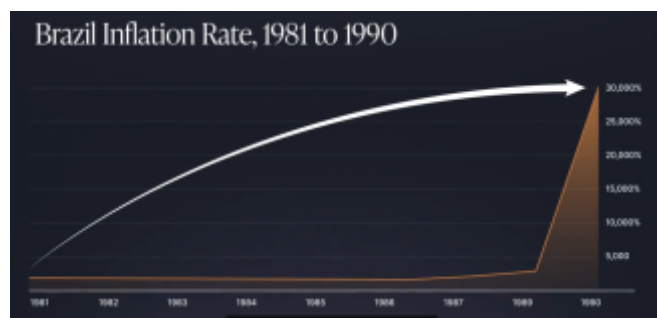
Again, that's a quote. And as I'll show you, this kind of sentiment and these ridiculous accusations are only going to escalate from here. So yeah, the election may be over, but these battles are just getting started.

Eifrig: It's wild. OK, today Porter will talk specifically about what this civil war will look like. And you'll also get into to exactly where and how the battles will be fought. Is that right?

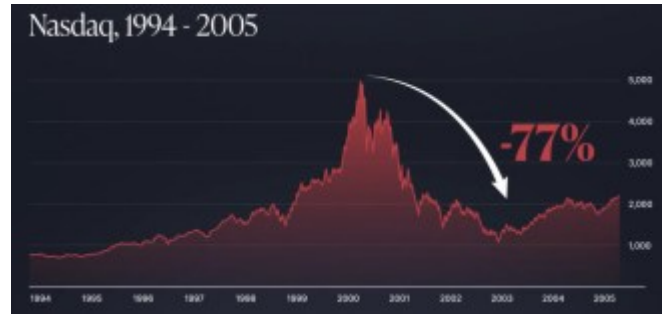
Stansberry: Yeah. And listen, no matter where you live, this is going to have a radical and permanent effect on the financial markets. And not just in the US, but all over the world. And there's one thing that you've got to understand before you leave here tonight. Which is most Americans have no idea that there has never been a more dangerous time to be a passive hands off investor in the United States than right now today. So even if you think you have a plan for the months ahead, I know what I can show you tonight is going to change your mind. The simple truth is because of what's happening right now at the very highest levels of government. We can't know. There's no way to know for sure if next year is going to be a continuation of the runaway inflation. Or even a terrible deflationary crash. But what we do know is that both paths are leading to America's next civil war.

Eifrig: Let's back up for a second to explain that. How do you think we can have massive inflation? And also deflationary crashes.

Stansberry: It's really simple. Markets are driven by the feds. Cheap money policies always lead to extremes, which in turn leads to huge deflationary busts eventually. And while I like many of Trump's plans, he's a real estate guy. Trump loves easy money policies more than anyone, and that means these big booms and the busts that follow are going to happen again. When I started in the financial world in the 1990s, easy money policies followed by Central bank tightening led country after country into debt default.

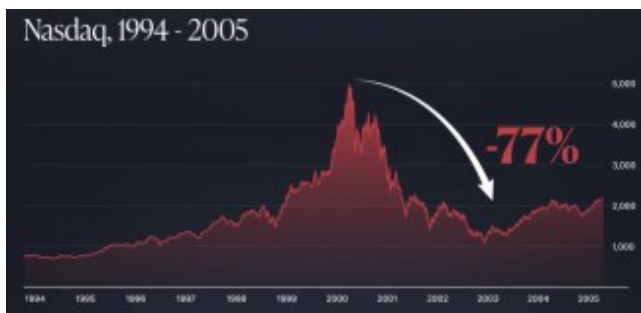
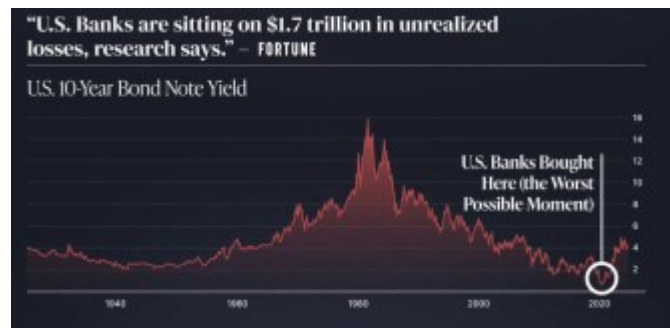

And I am telling you right now, you're going to see something very similar over the next few months. The next deflationary crash will be caused by the nearly \$2 trillion in debt that our banks took on at the absolute worst possible moment in history during the summer of 2020, when once again the Fed manipulated interest rates all the way down to 1%, leading to a credible boom and debt and inflation.

Brazil was the first one I saw blow up. Then Russia, Thailand. Then most of the Asian countries followed. Entire stock markets, in these situations, they fall as much as 75%. Then I'm sure you remember it was the telecom businesses in the early 2000s. Once again, artificially low interest rates led to extreme debt excess at companies like Worldcom and NCI. And the NASDAQ fell 77% during the bust that followed.



Our country has hit an incredible breaking point right there where there were two or maybe even 3 attempts on the president's life in a three-week period. We are heading into a civil war and this is unlike anything we've seen in America ever before. There's only one way out right now, and whether you take the time to learn about this right now or if you delay, this decision could define the rest of your life financially. And it will radically affect your portfolio if you do not take advantage of the things we're talking about tonight.

And everybody remembers the real estate frenzy of 2004 to about 2008. I'm sure everybody remembers, you know, watching their neighbors buying their third house and all the debt excess the strip-pers in Miami that had seven different mortgages. Well, all those things were caused by artificially low interest rates. And that led banks and individuals to do incredibly dumb things with money. You remember 2008, the entire stock market fell 57%.

Eifrig: Porter, I'm eager to get into the specifics of how you see America's next Civil War playing out and what the sides will be. Porter, you're calling for America's next civil war. Let's start there. What's going on exactly?

Stansberry: Well, Doc, I think you know I'm actually a very optimistic person by nature. And just to be clear, I still believe very strongly in the America that Doc you and I grew up in. I believe in our institutions and I believe in American exceptionalism. The American people are a uniquely honest and open people. And our country is ultimately destined for greater things. I believe all that and as I said earlier, while I like many of Trump's ideas like reducing taxes and cutting red tape, getting a handle on illegal immigration, I also believe that we are about to go through a very difficult time economically. Something terrifying is happening in America right now. And what I'm calling a civil war is looming. I'm sure most people find that hard or even impossible to believe. I'm sure

there's a lot of people watching just because they doubt me so much they want to see what it is I'm going to say. So let me start with three facts. And Doc, you know what facts are. Facts are things that whether or not you believe them, don't change, They exist without your consent. So there is no denying these facts and there's no denying that President Trump or anyone else can change them. They can't, and these 3 facts are what are leading inevitably to America's next civil war.

Eifrig: OK. Well, then, that's where we'll start. What's fact #1 Porter?

Stansberry: Alright, fact #1 is a tiny percentage of the American population now pays for everyone else.



The first thing you've got to understand is that. In America today, a tiny, tiny percentage of the population now pays for everything. Official stats show 346,000,000 people live in America so around 350 million. Guess how many people pay federal income taxes in America today?

Eifrig: Not many. It's a very low percentage.

Stansberry: According to the latest stats, there were 160 million individual federal income tax returns last year. But here's the catch. The bottom half of those filers, 80 million people or so don't pay any taxes at all to speak up, not a non material amount. In fact, the average household in the bottom half pays just \$667 in federal taxes for the entire year.



Eifrig: Yeah, these statistics always irk me upset me, amazed me, whatever you want.

Stansberry: OK, but it gets even crazier when you delve even further in the numbers. So the top 25% of tax filings now account for 90% of all federal income taxes. Some of these filings are individuals and some are couples filing jointly. But this equates to about 56

million people overall. That's roughly 16% of the entire US population, and that's the critical fact I want you to remember. About 16% of the US population pays almost all of our taxes.



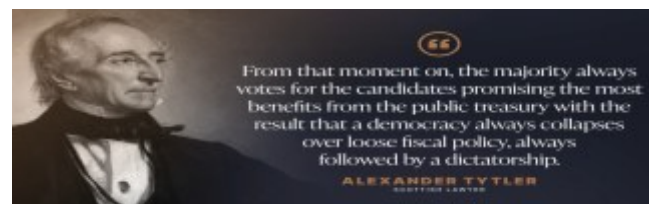
Doc, think about what those figures mean. In the most simple and basic terms, we have a system today where 16% of the people pay for everyone else. And my guess is if you're tuning in to this presentation tonight, you're probably part of the 16% of America that helps foot the bill for everyone in the country. Or you're certainly part of this group before you stopped working. You might be retired now but you definitely were a taxpayer before. And Doc listen, any way you look at this, this is a huge problem. I try to keep my personal views out of this equation. All I'm doing is what I've always done throughout my career. I'm following the research to its logical conclusions, even if that conclusion is controversial and people don't want to hear it.

Eifrig: Yeah. You and I have talked about this before and you touched on this earlier. Unfortunately, this is what inevitably happens in every democracy, right? Eventually people figure out they can vote themselves other people's money. And almost every economic student learns about a Scottish lawyer named Alexander Tytler who first pointed out this idea hundreds of years ago.

Stansberry: Yeah, Tytler studied how the average age of the world's greatest civilization was 200 years. We're at 248 years, by the way. And back then, Tytler predicted a democracy can only exist until the voters discover that they can vote themselves largesse from the public treasury.



From that moment on, the majority always votes for the candidates promising the most benefits from the public treasury with the result that a democracy always collapses over loose fiscal policy and is always followed by a dictatorship.



I've been writing about this problem for more than a decade and

clearly this is exactly where we are now in our evolution or de-evolution of a country. We are a nation that is made-up of a tiny number of producers and a huge majority of dependents who rely on the government in one way or another for their daily survival, Doc. According to the most recent numbers, the average American now gets 6 times as much money from the government compared to what they got in 1970. And let me be clear, that is after adjusting for inflation. That is, in real terms.

Eifrig: Yeah, the Wall Street Journal published a related study a few weeks ago about how people in 55% of Americas counties, 55% of America's counties could not survive without handouts from the government.



Stansberry: Yeah, that's right. More than half of the countries in the nation are completely dependent on federal government handouts.

Eifrig: And what's really surprising is that back in 1970, people in less than 1% of American counties received any meaningful handouts from the government. Boy, has that changed.

Stansberry: They've opened the floodgates and what's really happened and I hope that you guys will think about this deeply, not just in the economic sense, but in the political sense, what's happened is that we have become an entire society that's split into two. The one side relies on the government to survive and on the other side they have to pay for it. And when I say our side, I don't mean the top 1%. I'm talking about the hard-working 16% of the entire population that pays for virtually everything in our country today. And these are the two sides that are going to fight each other and America's, next, civil war. The dependent class now expects their debit cards to stay loaded. They expect their bills to be paid. They expect their college loans to be forgiven. They expect free medical care. They expect a free place to live. They expect free transportation. They look to someone else to provide them with everything. Through decades of conditioning and increasing American socialism, an entire generation of Americans has come to truly believe that you are entitled to your neighbor's money. But what happens if Trump does what he and Elon Musk have promised to do. Musk believes he could help cut 1/3 of the entire federal budget. That would be great, wouldn't it, Doc? He told The Washington Post, we can do at least 2 trillion with the promise of getting "the government off your back and out of your pocketbook." But what do you think is going to happen if the money pigots actually get turned off?

Eifrig: We'll have a lot of unhappy people.

Stansberry: Doc, there's going to be a kind of rioting and protests and looting you have not seen across this country in a very long time or ever in my lifetime. So that is fact #1, A tiny percentage of the American population is now expected to pay for everybody else.



And let's get to fact #2. We've now hit a breaking point and here is why. Fact #2 is the bill is now so high it can never be paid.



The second big problem is that the productive members of society are expected to pay a bill that we could no longer cover no matter how productive we are, no matter how many businesses we create. And no matter how much they try to make us pay in taxes. The scary truth is it is now mathematically impossible for the current group of American taxpayers to cover the paydays and the benefits that our government has promised. And it isn't even close.

Eifrig: Let's stop there for one second. I think it's important for folks to understand the math involved. See, there are basically three types of federal government spending in America. There's mandatory spending. There's discretionary spending and there's spending for interest on our debt. And what you're talking about here, Porter is only the mandatory spending, is that right? So that's things like Medicaid, Medicare, Social Security, disability payments, food stamps, unemployment payments, retirement benefits for government employees and more.

Stansberry: Yeah, all those direct transfer payments, they're actually mandated by law. And so it's not clear how Elon Musk and Trump are going to be able to cut them.

Eifrig: Yeah, and I think that's what many Americans don't realize is

that our mandatory spending is guaranteed by legal promises the government has made. It's written into law. And so what you're saying, Porter, is that these mandatory promises alone have bankrupted the government and are setting us up for a horrific crisis.

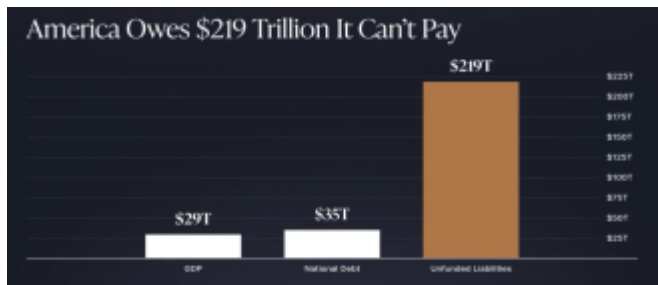
Stansberry: Exactly. Now, look, I don't want to get too deep in the weeds here. But it's really important that everybody understand a few basic numbers. So let's look at what the Congressional Budget Office reports about our spending. Today, the government's mandatory obligations, those are things that are mandated by law are just under \$4 trillion per year, OK, \$4 trillion is a lot of money. But the interest on our debt is now more than a trillion dollars per year. So you put those two things together. Those aren't options. You have to pay those monies \$5 trillion every year that the government absolutely has to pay by law, and that also happens to be exactly as much as we're bringing in via all of the taxes.



Not just income taxes. We are talking about corporate taxes, payroll taxes, duties, excise taxes, everything. And fiscal 2024, the United States government collected \$4.92 trillion in taxes.

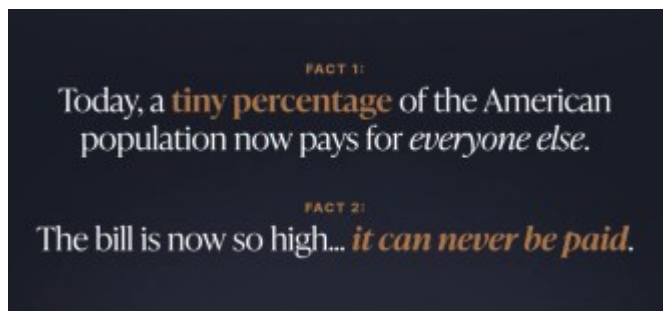


So that means there is basically no money at all leftover to pay for anything else in the entire budget. And by the way, the discretionary items are things like education, the military, infrastructure, we have \$0 tax money for any of this other stuff. You know, defense stuff that we really need. So over the long term, the numbers get even worse because we now owe, believe it or not, \$219 trillion more in mandatory benefits than the amount of revenue that we can bring in.



So I want you to let that figure sink in. The government has made

more than \$200 trillion in promises that it doesn't have any money to pay. And it's legally required to keep making these mandatory payments forever by any means necessary. And you know what that means. That means the printing press. So we're going to have to keep paying interest on the debt or we'll default and the entire economy will collapse. So when you look at the real numbers, and you really look at them, I think you can see why I'm saying that this debt will never, ever be paid off, even if millions of nonworking adults suddenly started paying taxes. It just wouldn't be enough. It wouldn't even be close. And even if Trump can cut a trillion dollars from the federal budget, it won't make any material difference. For the fiscal 2024 year, which just ended, we brought in 4.9 trillion. But Doc, we spent 6.75 trillion. So if you take a trillion off, we're still running a deficit. And those are the 1st and 2nd facts that every American has to understand. One is we're running the country on 16% of the population and two the government's budgets and debts are already too large to finance. We are already bankrupt.



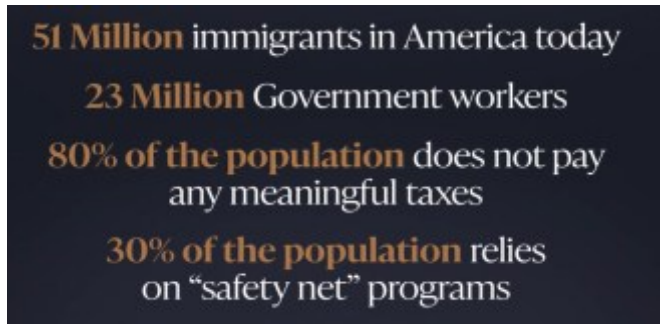
Eifrig: Yeah. And I think people should know that this comes from the Congressional Budget Office, which is this nonpartisan group. So this is not Democrats arguing the Republicans, or vice versa. Nonpartisan, their job is to show what the numbers are, what the facts are. So let me see if I can sum this up again, Porter. Fact number one, this small group, around 16% of the population is now expected and demanded to, and has been paying for everyone else. And fact #2 is the bill we're being asked to pay is far higher now than we could ever possibly cover, even if Trump could cut a trillion dollars from the budget, it's not going to matter. And this is the essence, the real root cause of America's next civil war. So what you're saying is that the Civil War is basically a fight over the government taking huge sums from some people and giving it to others.

Stansberry: That's right. That's exactly right. And one way or another, this way we've been operating is coming to an end. And when it does, it's going to trigger an incredible amount of anger and violence. Like I have said this before, I'll say it again. This is not a prediction that I'm excited about. It's just what is inevitable when you have economic situations like this that are going to hurt so many people. That is what is going to happen. So going forward, you are going to see an increasingly fierce battle between the fed up payers and the dependents. And what's going to happen, the only logical conclusion for this system that we are locked in is a civil war. This civil war is not North against South. It's not even believe it or not, Democrat versus Republican. It's just what you said. This is a fight over the government's history of taking huge sums of money from a small group of people and giving it to others. And then, of course, promising even more benefits that we can't ever pay for. And I just don't think most people realize how dependent the entire country has

become on those fraudulent promises.

Look we have 51 million immigrants. We've got 23 million people who work directly for the government Doc, directly. We've got 80% of the people who don't pay any meaningful amount of taxes and thus they're always going to be in favor of more government. Plus, we've got about 30% of the population, that's 100 million people that directly rely on these government safety net programs.



That is a whole lot of people, Doc. They're going to be extremely unhappy when they realize that it is not possible for the government to provide them the benefits they've been promised.

Eifrig: So what's going to happen? I mean, something's got to give, right? And no matter how you look at it, the government has these huge bills to pay. And even if raising taxes would solve the problem, which it won't, Trump would never do that. He's going to be cutting taxes, not raising them. What do you think happens next?

Stansberry: Well, you know, that's a big question, but one of the very first things that Trump said is promises made, promises delivered, right? Look at what he's done with his cabinet. He is going to cut taxes. He is going to raise tariffs. He's going to do what he promised to do. And something is going to give, Another way of looking at this is think about what has to happen here. Well, let me tell you what, let's just get to the third fact before we get to a prediction. Let me let me tell you the third fact and again I want to reiterate to everybody, facts are things that will not change, whether you believe them or not. So you can disagree with my conclusions or my predictions. You can't disagree with these facts,

So fact #3. Let me tell you what's about to break in America.

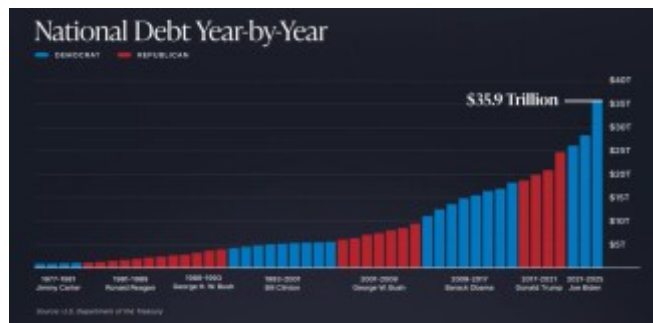


Trump's got just one path going forward. And sure, maybe he will raise tariffs. Maybe he will be able to cut as much as a trillion dollars out of the federal budget. I don't know from where. I don't know

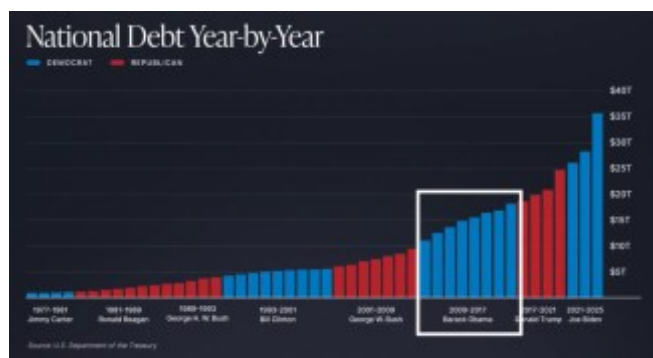
how it's possible. But the truth is they're simply not, and they're never will be enough money coming from the top 1% or even the top 25%, or even the top 50% to pay all of our bills. So Trump's only viable solution is to do exactly what he did in his first presidential term. Borrow and print more money in even greater amounts, and at a faster pace than we have ever seen before.

Eifrig: Hold on, hold on. People are probably going to say so what? We've been printing and borrowing trillions for years. Does it really matter now?

Stansberry: Yeah, it matters. It always mattered, but it really matters now because we have hit a tipping point economically and I can explain what that is. The acceleration of the rate at which we are borrowing money is truly mind-blowing.

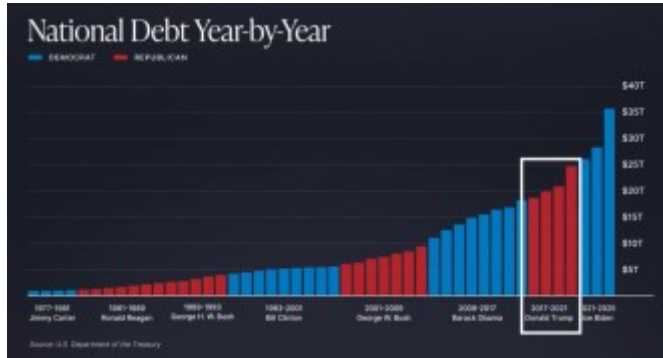


During Barack Obama's presidency, the total US outstanding debt increased by almost 8 1/2 trillion dollars. I think it was \$8.3 trillion, and that was the biggest dollar increase of any president in history to U.S. debt.

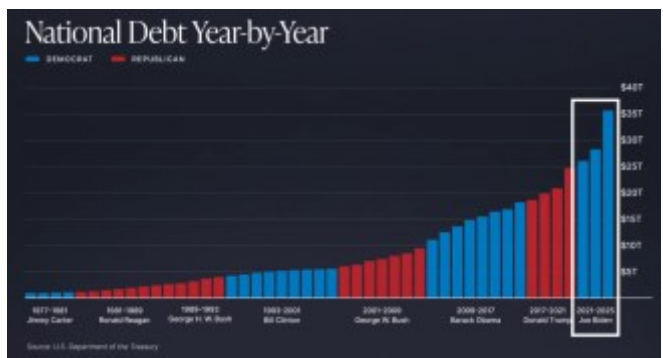


The debt increased by about 8 trillion during Donald Trump's first presidency \$8.1 technically. But about \$8 trillion. And sure, a large portion of that big increase to debt was due to the COVID relief. But anyway you look at it, Trump almost matched Obama's reckless spending in half the time. Obama was president for eight years. Trump was only president for four.

And then came Biden. Oh my gosh, Doc. The Biden administration is averaging a trillion dollars in new debt every 100 days.



That's a pace of debt acceleration that's going to add \$3 trillion in new debt every single year. So that's \$12 trillion in new debt for a single presidential term. That's a 50% increase to Obama and to Trump. So what's going to happen in Trump's next term? As my friend, the former Reagan advisor David Stockman says "Donald Trump is the king of debt, and when you compare the rate of spending growth in constant dollars going all the way back to President Carter, President Trump has spent more money than anybody by a wide margin".

So again, I want to, you know, be clear. I like a lot of Trump's ideas, but there is no reason to believe that he is going to actually cut government spending. I think it's very obvious that he won't. And this reminds me of something. Some historical context, a lot of our subscribers remember when Reagan came to office in the early 1980s following the Carter Years and the Carter Years were sort of out of control, government spending, big inflationary pressures and everybody expected that Reagan was going to balance the budget and be a

conservative president. Of course, that's not what happened at all. He massively increased government spending and government debts and so you know the stock market took off and it was good for the economy because back then we had a very low level of debt and we can still finance it. But that is just not true anymore.

Eifrig: Why do you think it matters now then?

Stansberry: Well, look, since 2008 the Fed and the Treasury have had to paper over all these financial problems in America because we can no longer finance these debts. And of course, the huge losses that we've had in the banking system too. So where did all the losses from the mortgage debacle in 2008 really go? The answer is they all got swept into the US Treasury. Why? Well, it's because the government papered over those enormous debts. They printed the money to buy the bonds so they could finance all these losses and all those losses are still in the system. They just keep getting moved around. It's kind of like a giant game of whack a mole. Oh, you know, residential mortgages are crashing. We'll print. Oh geez, the treasury bond market is crashing. We'll print. Oh geez, commercial real estate is crashing. We'll print. Oh geez, we have to shut down the economy for COVID. We'll print. And wait until you see what happens next. The biggest banks in America are sitting on \$1.7 trillion in unrealized losses because they bought long term government bonds with 1% yields when the Fed had manipulated the interest rates to the lowest time in history.



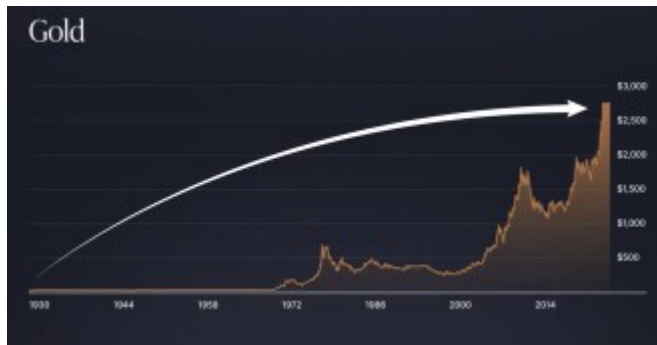
I call these the COVID bonds. This is the bonds that were for sale in about July of 2020 and the losses on this cohort of bonds is going to be the single biggest losses in the history of the financial markets. All of these losses are going to come out of your pocket and my pocket and everyone else's pocket. That's because we're all holders of the dollar and so all the money that's going to have to get printed to cover over yet more losses are going to come out of our purchasing power, going to come out of our wages. And they're also, by the way, going to come out of our foreign trading partners and all of our foreign creditors. And that is the biggest risk. The real risk is that as people here and around the world figure out that the dollar itself is broken, then everyone's going to start to flee the dollar and that would have absolutely enormous consequences for the entire world. Soon we are going to lose control of the currency. We are already losing control of the bond market.

Eifrig: I agree with you on that one. Just look how the Fed cut short term rates recently. But what happened? Long term rates have skyrocketed higher. And if when anyone tells you to own a long term

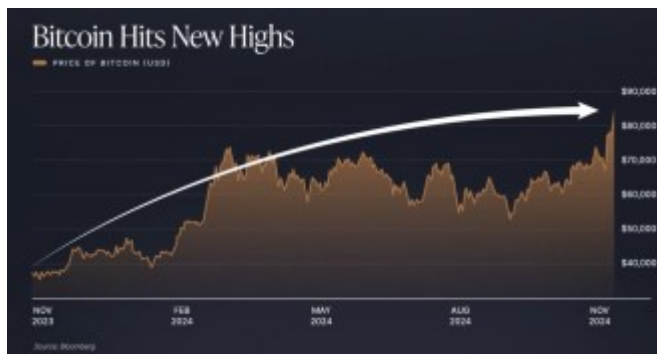

government bond right now, you should tell them to take a hike. It's financial suicide and this happened because the Fed can't control long term interest rates and people are demanding more and more interest to own these long term US. Government bonds. And so the Fed really is lost control of the longer data, the bond market. I know we've both been talking about these problems for more than a decade. But these issues can take a long time to develop. And now the stuff you started writing about in the End of America book more than a decade ago, it seems to be happening more and more.

Stanberry: It is absolutely happening. That hypothesis has continued to develop and as long as this goes on, and it certainly is going to continue, you should expect to see much higher rates of inflation which passes the losses on to anyone who's holding US. Dollars. But, you're also going to see that, punctuated by very intense short periods of deflationary collapse. Remember these easy money policies always lead to massive excesses. Massive excesses in government spending. Massive excesses in debt, massive processes in the financial markets which we have seen stocks trading at crazy prices. But that in turn eventually leads to a huge crash. It's the constant debasement of our money that's causing gold and Bitcoin and stock prices to soar.



Think about it. Gold pays no interest. It does nothing but hedge against government currencies and it's up 40% in the last year. It's now at all time highs. Stocks soared 1000 points the day after Trump got reelected. Why? Because they know he's gonna spend. Bitcoin shot up more than 10% the same day. Same reason Bitcoin doesn't pay any interest. It's basically digital gold and it's up more than 100% in the past year. If you own these assets, that's great.



It's a good start, but today I'd like to show you something that's far better. Far better. Better than these obvious choices and safer, and I'm really excited to show people this incredible strategy. It is a very simple way to protect your entire portfolio in the years to come, specifically from these kinds of economic problems, and it's something that we have never detailed here before. They're going to say that it's our fault. That we gained at the expense of the working class and of course we did. But it wasn't our fault. We just took steps to protect ourselves. I promise you, Doc, a war is coming between those who have benefited from the current pre Trump regime and those who have to pay for it. And like I said, this war won't take place on battlefields with uniformed armies. That's not how civil wars are fought anymore. Instead, it's going to be fought in the neighborhoods and in the streets by radical terrorist groups. Tremendous violence on both sides. It will be fought in the media and the courts and in the local state and federal legislatures. Think about the Irish Civil War from 1916 until the late 1990s.



That's the kind of civil war we're going to see, neighbor against neighbor, extreme violence.

Eifrig: Yeah, you know, a lot of people look at the January 6th capi-

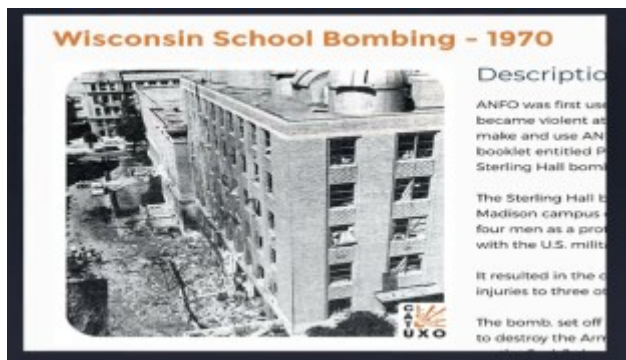

tal attacks and believe it's only the far right who are aggressive and violent. But many people forget how violent the far left got the last time inflation soared, the last time our currency neared a complete collapse. And that was the early 1970s.

Most people don't remember what it was really like during that time. And it's rarely ever talked about in the history books. But according to the FBI, during one 18 month stretch there was an average of five bombings per day in America in 1971.



Stansberry: That's right. That part of our history has been completely swept under the rug. And we're about to get a really dangerous refresher course. That's exactly the kind of behavior that we're about to see again because wealth and the free market are going to be delegitimized by the people who are impoverished by inflation. Eifrig: Yeah, they smuggled bombs and the skyscrapers and federal buildings from coast to coast. I remember being at the University of Wisconsin walking by a genetics class and there was a plaque, not commemorating, but recalling the history of the bombing from those days. And I wasn't even aware of it that moment. I went, what? And I think two or three people were killed at the University of Wisconsin campus.



They struck inside the Pentagon, the US capital. At a courthouse in Boston, at dozens of multinational corporations. At a Wall Street restaurant packed with lunchtime guests. And people died, properties were destroyed and it went on for years too. With the police doing essentially nothing. They robbed dozens of banks, launched raids against the National Guard arsenals, assassinated policemen in New York, San Francisco, Atlanta. They got in deadly shootouts and even a jailbreak. They broke into government buildings in DC.

Stansberry: Yeah, Doc, as you know, these bombings and robberies and shootouts, they stretched from coast to coast, Seattle to Miami, Los Angeles to Maine. The people were at war against their own country, against their own government. As one militant member said after being captured after 12 years of hiding underground "People always ask me why I did what I did and I tell them I was a soldier in a war." Doc, I'm really worried about this. And there's people who believe that Trump is the next Hitler. One left wing commentator called Trump's win worse than 9/11. Another thing most Americans don't realize is how eerily similar today

Eifrig: Yeah, that's terrifying to think about the violence that would ensue and worse, I can't imagine JD Vance at the helm either.

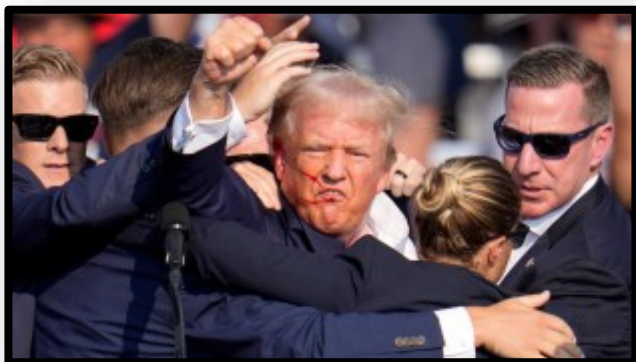

Redacted: Well, a huge day in Washington, DC, as President Trump met with outgoing President Biden and thanked him for a "smooth

transition". Stone: Yeah, I think we have to absolutely assume that they're up to something diabolical because these kind of people particularly do not give up power voluntarily. The will of the people means nothing to them. They proved that in 2020 and the president's mandate now is so broad, so sweeping he really is in an extraordinarily strong position to forge an entire golden age of America. We could have the most unprecedented peace, prosperity, opportunity and justice and security this country has ever seen. But to do that he is going to have to dismantle our current elite cabal, that in conjunction with their allies and media, have a very different idea about America. So my number one concern is his safety. Now, if there hadn't already been two assassination attempts against him that we know of, you might say, well, that's just a conspiracy theory. Redacted: It's terrifying, and especially when, yes, we've had all of the failures of the Secret Service over the past couple of months. And now he gets to appoint the head of the Secret Service. Somebody's going to protect him. He gets to pick his own security detail in many ways and make sure that he is safe and secure. And in many ways that might be the most important appointment that he makes.

Stone: Yeah, I completely agree. I also agree with something that our friend Sean Hannity often says. The problem in all these agencies are not in the middle or the lower levels of the agency. I think you have a lot of good men and women there who are committed, you know to the rule of law and to doing their job. The problem lies at the leadership levels of these organizations. When my home was raided by 29 fully SWAT clad FBI agents brandishing fully automatic M4 assault weapons, they were in my house for 13 hours. They would look at you and roll their eyes, that they would wink at you, like as if to say I don't want to be here. I don't want to be here. I'm doing this because I was ordered to do it. So I do think we need somebody at the top of the FBI, particularly of the Central Intelligence Agency, particularly of the Secret Service, particularly, who's prepared to clean out those agencies and ensure that those who are there are committed to the rule of law and the protection of the President and the country.

Redacted: You mentioned the "Lawfare" piece of this coming to your house and all of that, and then everything they've been going after Trump. It seems to me that there's a respite. Now Jack Smith is set to maybe step down, pulling back on his prosecutions. But then you have Leticia James in New York saying we're ready we're bating down the hatches, we're getting ready. Back when she was on the City Council, remember a contribution to the New York City Council of under \$250 gets put through a ten to one campaign finance match. So if the money was illegal to begin with, and much of it I can prove was, and then was matched with the taxpayer's money, there's two violations there. Two very serious violations. It's kind of like with Eric Adams. No, this was not that he just got a coach ticket bumped up to first class or that he got an extra Bloody Mary. He took \$10,000 from Turkey illegally. 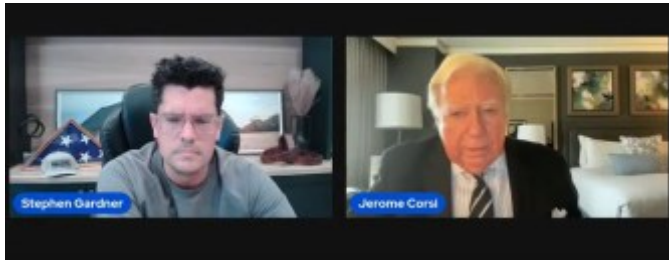

The breaking news out this morning is that President Trump is suing the *New York Times*, *CBS News* and a couple other news outlets for \$10 billion. According to Trump's legal team, they used false and defamatory statements. They took it too far, and Trump believes that they are the full-throated mouthpiece of the Democrat Party. Any chance that these defamation and libel lawsuits go anywhere?

Corsi: Well, I think that of course you'll have freedom of the press argued and defense of the newspapers, but the defamation is clearly what they did and the lying, the distortion, the misrepresentation of honest information, they were politically motivated, all these publications. And the censorship, it's been tremendous. So I think for the first time maybe in American history, some of these major newspapers and media are going to face charges that they're no longer acting as media. They're acting politically, they're politically motivated, and as such they're going to lose some of their First Amendment protections, especially in defamation. So again, I think the intent to damage Trump's career and put him in prison to destroy his presidential ambitions, these are things that are malicious use of the 1st Amendment privileges that newspapers have and I'm quite frankly, following this with very close attention because I wrote my doctoral dissertation at Harvard on political science on the 1st Amendment. Gardner: OK, thank you for that. You wrote on Twitter that the Democrats are revealing their true selves through post Election Day weasel tactics. What do you mean by that?

Corsi: Well, I wrote an article in *American Thinker* that was saying that essentially the Democrats are not finished yet. Jack Kennedy said he was going to break the CIA into 1000 pieces and he didn't do it. Well, that was signing his death warrant because he put the CIA on notice he was going to come after them. So Trump has now put on notice a variety of agencies, including the FBI, Department of Justice, the CIA, maybe the National Security Agency, certainly the intelligence apparatus of the United States and the justice apparatus that he's coming after them. And so therefore, they're going to retaliate. I mean, they're like cornered. And the number of these people. John Brennan comes to mind immediately. As former head of the CIA for a lot of their lying, these 50 CIA agents who said that Hunter Biden's laptop was Russian propaganda, they did that in the 2020 election to take that issue off the table. They were lying. There's a lot of people who really, I think, and the intelligence community know that the agencies are going to be disbanded. Donald Trump is going to come after criminal prosecutions for some of them. And some of them may have even committed treason. And certainly, these attempts to interfere with the election by attacking the very fundamentals of election integrity, which the Democrats don't seem to have seen any scheme to lie, cheat and steal elections they don't like as wrong. They don't really want elections to be fair. Well, these are bordering on treason. And I think fundamentally, we've got to put them on notice that treason charges are not off the table. Again, it's a very dangerous game to do, threatening it. It's better to start it and then actually get it going. So Trump could have waited two months, put his team in place, let people make their inferences and then given the marching orders to go to war against the deep state. Instead, the deep state has gone to war against him. Now there are several things I'm worried about. Number one is that this judge in New York, Judge Merchan for a New York County case. This is the Stormy Daniels case and Trump has 34 convictions on felonies in that case, I think the whole case is a ridiculous case. I think it will be dismissed on appeal, but the point is that judge could demand Trump come in for sentencing which was originally scheduled in September 26 and it could incarcerate Trump. Well, if Trump is incarcerated, his life is at risk. And again, I don't think this deep state has much choice. I think a third assassination attempt is now on the table. I think that they're going to do everything they can to try to block Trump from getting into the White House. Which means lawfare is going to start to happen. You know the idea that Trump would be in prison and when the electoral college is to meet they would have riots in the streets. Well, again, all these things, the deep state is prepared to come down hard on. I'm going to read a couple more articles. The one article is going to be these national security classifications. I just was studying them, coming on the train to Washington I was looking at these various national security directives to come out of the Department of Defense. A directive that was in 2024, a directive numbered 5240.01, allows the military to use lethal force if called out to support civilian law enforcement in situations where a confrontation between civilian enforcement and civilian individuals or group is reasonably anticipated. And that's in the discretion of the Department of Defense. The previous Department of Defense directive demanded that they be authorized by the President. So this is a loosening of those regulations and I think it's for reasons where the deep state, if it can foment any violence in the street, especially if they can blame it on pro Trump groups, would not be hesitant to utilize the military. I think we're also going to see schemes coming up in lawfare to rig the

Electoral College. Remember 2016, they tried this Hamilton electors, which is saying that the electorates did not have to vote the way their states voted. And that on character the states pledged to Donald Trump electors could change and vote at that time for the Democrat. They're going to be trying all these schemes. We're going to hear a bunch of them. Now, I'm not sure that the schemes are going to be used because I think that Trump had such a mandate in this election, the Democrats refrained from the steal tactics, I think largely because of the algorithms we revealed. Gardner: OK, I know when Trump came in in 2017, Senator Chuck Schumer said that the intelligence agencies have seven ways from Sunday to get back at you and that he had foolishly provoked them. One of my worries, Doctor Corsi is he's created this dream team like I've never seen before. People are very excited about it, and yet, theoretically, all of those people could now have a target on their back and I think one of the main outcomes of the JFK assassination was, hey, even a president can be taken out if they're not doing what we want. My worry is any of these you know, seven or eight big names could also have targets on their back and if something happened to one of them, that would put fear into the entire populace. Do you worry about Elon Musk, and that they can RFK junior all of them. Do you worry about them now having targets on their back?

Corsi: Well, I think they need to get as tight security as they can get, including private security, and I'm sure they'll invest in private security and you know, we could help them do that. I've got enough security ties that I know professional security firms that would be glad to provide security for any of these people. But the point is that yes, they're going to be targeted. And the first salvos will be like you've seen against Matt Gaetz and Hegseth, recently where they're going to try to say there's morality charges, you know. They've had affairs with underage girls or they're going to try to produce all of the dirt they can on these people, which is largely unfounded. I don't think that's going to go anywhere. Although you know there's evidently a congressional investigation going on Gaetz right now that will be released. I don't think these charges have any real foundation. Certainly not that I can see. And I've examined where the charges came from and who started propagating them. They seemed to me to be typical WOKE insanity fiction like the Russian collusion, had no basis in reality. None of these things have to these are just things to to slur and damage a person's character and career. I think that the Trump nominees are going to have to go through that round and then when they get in office, they're going to have to be protected. But what has to happen is enough quick action, another words, enough talking about what we're going to do. We've got two months here where Trump can put the team in place. I would encourage him to stay largely at Mar-a-Lago. I know he's going to want to do things

like attend events, the fight in Madison Square Garden, for instance, coming up. I'm sure he'll be there. You know he's going to be wanting to be public. Well, this will be a good time, he doesn't need to be campaigning anymore. He could just be staying in Mar-a-Lago and staying safe until the inauguration when he gets another level of protection from the Secret Service. And I think he would be wise to bear in mind that with two assassination attempts it could easily be a third. The second point is when we do get into power, assuming we get through all the lawfare that's going to go on with the Electoral College, with the military, with the potential for violence in the streets, we have two months here with the Democrats extreme left is going to be unhappy enough that they're going to want to pull some stunts and they're going to try to be vigilant and call them out on it and they hate the Electoral College. Let's get all this information as quickly as possible to the public. Let's make Julian Assange's efforts look minor. Once we've got control of these agencies and let's publish everything. Corsi: I have no doubt about it. I'm doing a lot of writing in American Thinker right now. I've got I outlined 3 separate investigations I think Trump is going to do. Number one he is going to do an investigation of the two assassination attempts on his life. I think he's got indisputable evidence that some in the Secret Service and the Department of Homeland Security display criminal negligence in allowing the attacks to happen. He is going to force those individuals to cooperate with the special counsel. And he's going to expose, going back to Jack Kennedy, the CIA and the secret services involvement in killing Kennedy. And my book on the assassination of John F Kennedy, the final analysis showed the forensic evidence from the X-rays that Jack Kennedy was shot twice from the front. It's going to come out that we've been lied to for 60 years by the intelligence agencies. Now, why did buildings that were not hit by airplanes on 9/11, why did building number 7 or six come down. We

Gardner: OK, those are all things that I think myself and my audience would love to get answers on as a starting place. You're a JFK expert. Just announcing him as Health and Human Services Secretary wiped out billions of dollars in stock value of Big Pharma stock companies. He wants to look at the vaccine schedule. He wants to look at the 1000 plus food additives that are poisoning America. Chronic illness. But there's a lot of money, there's a lot of incentive to keep us sick. There's money in sickness, not in health. What are your thoughts on him being named and is he the one in most danger based on his mission.

Corsi: First of all, Robert Kennedy has been very complimentary to me about the book that I co-authored with Doctor David Mantik on the JFK's skull X-rays and the autopsy collection of the archives. And he was very, very much impressed with the quality of that book. The book as you know is *The Assassination of John F Kennedy*, the final analysis, and it did prove convincingly that Jack Kennedy was shot twice from the front. Robert Kennedy's is going to face many threats of assassination He's got to know his life is now at risk. But again, the protection in that. First of all, I think he's going to have to seek protection from God. That's number one. And Donald Trump obviously had protection. The hand of God was on him, especially in that Pennsylvania shooting where he just turned his head at the right split moment and the shot, which I'm sure had been laser sighted to hit him in the head, but it glanced and hit his ear. That's miraculous. The one thing that Robert Kennedy's got is if he were, you know, if he were to fall down the sidewalk and scrape his knee, Big Pharma would be blamed. And so Big Pharma in that sense ought to keep Robert Kennedy a safe. The big vengeance in the American people if something happens to Donald Trump or to you know, to Robert Kennedy is going to be strong. But the sense of the deep state count-

President-elect Donald Trump has made a number of sweeping proposals for a second term in office, outlining a wide-ranging agenda that targets **federal regulations, taxes, immigration, and social issues.**

Early Nov 6, the former president and president-elect claimed victory in the 2024 presidential contest, telling supporters that voters had given him an “unprecedented and powerful mandate.” Early projections showed that Trump may win not only the Electoral College but also the popular vote, something he’s never done in his previous two campaigns.

Immigration

Since 2015, Trump has made curbing illegal immigration a cornerstone of his campaigns. As president, he built or reconstructed about 400 miles of border barrier along the U.S.–Mexico border and implemented a number of rules curbing illegal migration into the country.

During the campaign, **Trump often said that he would initiate the largest “mass deportation” effort in U.S. history if elected.** Recently, he also warned Mexico that **he would impose a 25 percent tariff targeting the country if it fails to curb illegal immigration** and that he would raise that tariff if Mexico doesn’t comply.

Also, he’s suggested more enhanced screenings for immigrants, ending birthright citizenship—which may require a constitutional amendment—and reimposing certain policies enacted during his first term such as the “remain in Mexico” protocol.

Tom Homan, a former acting director of U.S. Immigration and Customs Enforcement (ICE) who is expected to join the new administration, told media outlets last year that **the scale of deportations depends on what resources are available.**

During a “60 Minutes” interview in October, Homan was asked about whether families would be separated. Homan responded, “Families can be deported together.”

Vice President-elect JD Vance said in his debate with Minnesota Gov. Tim Walz on Oct. 1 that deporting criminals would be a second Trump administration’s initial focus.

“You’ve got to reimplement Donald Trump’s border policies, build the wall, reimplement deportations,” Vance said, adding that the United States has 20 to 25 million illegal immigrants in the country. “What do we do with them? I think the first thing that we do is we start with the criminal migrants.”

Trump's Proposed Programs

Taxes and Regulations

Throughout the 2024 campaign, Trump has promised to curb federal regulations that he said would limit the creation of new U.S. jobs. He also has pledged to keep intact a 2017 tax cut that he supported and signed while in office.

His team has also proposed a further round of individual and corporate tax cuts beyond those initiated in his first term.

Trump has pledged to reduce the corporate tax rate from 21 percent to 15 percent for companies that make their products in the United States. In a bid to win Nevada, Trump earlier this year pledged to end the taxation of tips and overtime wages to aid some service workers and waiters.

He has pledged not to tax or cut Social Security benefits. Trump also has said that as president, he would pressure the Federal Reserve to lower interest rates but wouldn't make any demands on the central bank.

Some of his proposals would require congressional action. (the GOP retook the Senate, but the picture around the House is murkier).

Tariffs

In multiple campaign stops this year, Trump floated the idea of a 10 percent or more tariff on all goods imported into the United States, which he said would eliminate the country's trade deficit.

He has also said he should have the authority to set higher tariffs on countries that have put tariffs on U.S. imports. He has threatened to impose a 200 percent tariff on some imported cars, saying he is determined in particular to keep cars from Mexico from coming into the country.

Trump has targeted China in particular. He proposes phasing out Chinese imports of goods such as electronics, steel, and pharmaceuticals over four years. He seeks to prohibit Chinese companies from owning U.S. real estate and infrastructure in the energy and tech sectors.

"To me, the most beautiful word in the dictionary is 'tariffs,'" Trump said in an interview with John Micklethwait, editor-in-chief of Bloomberg News, in October. "It's my favorite word."

He added at the time, "**You see these empty, old, beautiful steel mills and factories that are empty and falling down,**" referring to facilities that used to make goods in the United States.

"We're going to bring the companies back. We're going to lower taxes for companies that are going to make their products in the USA. And we're going to protect those companies with strong tariffs," Trump said.

Micklethwait said that some economists have projected that the former president's economic policies, including tariffs, could add trillions to the U.S. deficit. But Trump said that a number of countries, including "allies" have "taken advantage of us, more so than our enemies."

More Drilling

The former president said that he wants to cut federal regulations on drilling for oil and natural gas, a move that he says would lower energy costs and inflation. In multiple instances, Trump said he would reauthorize drilling in the Arctic National Wildlife Refuge in Alaska, which was suspended under the Biden administration.

Meanwhile, he would pull the United States out of the Paris Climate Accords, a worldwide plan that claims to reduce carbon emissions. Trump also said he would roll back some federal policies around electric vehicles.

In his campaign, Trump has often said that gas prices were much lower under his administration than they have been under the Biden administration. He has suggested that prices would again fall when he takes office.

"When I left office ... gasoline had reached \$1.87 a gallon. We actually had many months where it was lower than that," Trump told reporters over the summer. **"But we hit \$1.87, which was a perfect place, an absolutely beautiful number."**

According to AAA, the average price for a gallon of regular gasoline stands at around \$3.10. The highest recorded average price for a gallon was on June 14, 2022, when it reached \$5.01, AAA figures show. The federal Energy Information Administration's data show that the average annual price for a gallon of gasoline did not exceed \$3 under the first Trump administration.

Social Policies

Trump has pledged to require U.S. colleges and universities to "defend American tradition and Western civilization" and to purge them of diversity and inclusion programs, which he and Republicans have said

are leftist in nature.

He said he would direct the Justice Department to pursue civil rights cases against schools that engage in racial discrimination. At K–12 schools, Trump would support programs allowing parents to use public funds for private or religious instruction. Trump also wants to abolish the federal Department of Education and leave states in control of schooling.

Regarding abortion, **Trump has said that a federal ban on abortion is not needed and that the issue should be resolved by states.** He's also said he backs rules that advance in vitro fertilization, birth control, and prenatal care.

In campaign events and interviews, Trump has been critical of schools allowing transgender individuals to compete in women's sports, saying that he would impose a ban on such practices.

"It's a man playing in the game," Trump said at an October town hall event. "Look at what's happened in swimming. Look at the records that are being broken." *Reuters contributed to this report.*

"Pam was a prosecutor for nearly 20 years, where she was very tough on violent criminals, and made the streets safe for Florida families," Trump wrote on Truth Social.

The president-elect said that as Florida's first female attorney general, Bondi "worked to stop the trafficking of deadly drugs, and reduce the tragedy of fentanyl overdose deaths, which have destroyed many families across our country."

In his statement, Trump cited one of her notable moves leading her state: "Kristi has been very strong on Border Security. And he wants to end the chronic disease epidemic with measurable impacts on a diminishment of chronic disease within two years."

If confirmed by the Senate, the role would give Kennedy, a former independent presidential candidate who has a history of spreading conspiracy theories, including about vaccines, the chance to actualize a vision of public health that is often at odds with mainstream health and science. Dr. Benjamin Jin, a biologist, works on immunotherapy for HPV+ cancers, in a lab at the National Cancer Institute at the National Institutes of Health (NIH) in Bethesda, Md. in 2018. The NIH funds research into cancer treatments among many other diseases. Experimental trials are ongoing at the National Institutes of Health Clinical Center, a US government-funded research hospital where doctors are trying to partially replace patients' immune systems with T-cells that would specifically attack cancers caused by the human papillomavirus (HPV), a common sexually transmitted infection. A person's T-cells will naturally try to kill off any invader, including cancer, but usually fall short because tumors can mutate, hide, or simply overpower the immune system. Immunotherapies that have seen widespread success, such as chimeric antigen receptor (CAR-T) cell therapies, mainly target blood cancers like lymphoma, myeloma and leukemia, which have a tumor antigen -- like a flag or a signal -- on the surface of the cells so it is easy for immune cells to find and target the harmful cells. But many common cancers lack this clear, surface signal. Hinrichs' approach focuses on HPV tumors because they contain viral antigens that the immune system can easily recognize.

"Mike has been a great public servant, Governor, and Leader in Faith for many years," Trump wrote in a statement announcing his intention to nominate Huckabee. Who Voted for Trump



Congratulations to Donald Trump for his big victory over Kamala Harris in the November presidential election. In this article, I will refrain from covering the political reasons I believe Donald Trump beat Kamala Harris, except that Trump articulated his planned policies far more persuasively than Harris ever could. Instead, this article will report who voted for Trump compared to Harris.

Here is a table showing the raw election vote for Donald Trump in 2020 and 2024, in contrast to the raw vote for Biden in 2020 and Harris in 2024.

Trump won ALL seven battleground states (Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania, and Wisconsin), receiving 312 total electoral votes out of a total of 538. Harris received 226 votes.

The following article by the *Epoch Times* on Nov 9, 2024, breaks down those who voted for Donald Trump, which led to his presidential victory.

This week’s election victory for President-elect Donald Trump marked not just his historic political comeback, but also a broader coalition that included many groups that had not voted for him by the same margins in previous years.

One of the most decisive crossovers for Trump was Generation Z voters aged 18 to 29. Forty-six percent voted for him this year compared to 36 percent in 2020, according to AP VoteCast.

According to the Edison Research exit poll, almost half of Gen Z men, 49 percent to Vice President Harris’s 47, broke for Trump.

But it was not just with younger voters—Trump also increased his share of support among black voters by 7 percent and Hispanic voters by 7 percent.

The president-elect saw an opening by going on podcasts throughout his busy campaign schedule, including an October appearance on the Joe Rogan Experience, which has millions of subscribers, particularly among Millennials and GenZs.

While his Democratic opponent, Harris, spoke on other podcasts like “Call Her Daddy,” which focuses on young women’s issues, she declined to appear on Rogan at the last minute after her campaign and the host disagreed over the format.

Trump also teamed up with X CEO Elon Musk, who had a 25-point net favorability in an October YouGov poll, with an interview appearance on the billionaire’s social media network that was streamed by millions.

The president-elect has also leaned heavily into meme culture, which is particularly popular among young Americans. And while the Harris campaign tried to do much of the same with “brat” memes inspired by British pop singer Charli XCX, the efforts did not galvanize the same sort of reactions among Gen Z.

Beyond Trump’s presence on nontraditional media, which younger Americans have gravitated to in recent years, exit poll data suggest that most said the economy was the most important issue affecting their votes this year.

Nearly two in five voters named the economy as the country’s most important issue, according to AP VoteCast, with a higher proportion in the battleground states of Georgia, Michigan, Pennsylvania, and Nevada.

While some wondered if abortion would galvanize women in supporting Harris after Trump took credit for overturning *Roe v. Wade*, he increased his share of women voters aged 18 to 44 by 6 points, while seeing largely the same margins among women older than 45 and suburban women.

Trump’s victory can also be credited to his increase in support among Hispanic Americans, securing 42 percent of the Latino vote in 2024 compared to 35 in 2020.

The National Election Pool exit poll, however, found Trump winning 45 percent of Hispanic voters among 22,800 votes cast in key states, with 54 percent of Latino men backing the president-elect.

Among black voters, Trump secured 16 percent of their vote in 2024, doubling his 8 percent figure from 2020, according to AP VoteCast.

But among white voters, Trump lost some ground, according to the National Election Pool, with him seeing a 3 percent decrease in support among white women since the 2020 election.

Trump also made double-digit gains in two blue states controlled by Democrats—New York and New Jersey—while increasing his mar-

gin of votes in California and Illinois compared to four years ago.

After losing New Jersey to then-candidate Joe Biden by 12 percent in 2020, Trump was only trailing Harris by 5 percent in the Garden State (as of Nov 8).

The president-elect also flipped five New Jersey counties red—Morris, Passaic, Gloucester, Cumberland, and Atlantic.

A similar scenario played out in New York, where Biden had won by 23 points in 2020, but Harris had reduced that lead by half—11 percent—as of Nov 8).

Trump also flipped three New York counties that voted for Biden in 2020 and Hillary Clinton in 2016—Nassau, Clinton, and Rockland, according to election data, while also winning Broome and Essex, which Biden had won but Clinton had lost.

Within New York City, long considered a Democratic stronghold, Trump saw a 5 percent increase in Brooklyn, a 10-point increase in Queens, an 11 percent increase in the Bronx, and a 5-point increase in Manhattan.

Trump improved in Illinois as well, increasing his 40 percent of support in 2020 to 45 percent this year.

Even though California still has millions of ballots left to count, Trump is on track to increase his margin by 5 percent since 2020, garnering 39.8 percent of the vote so far, compared to 34.2 percent four years ago.

Although many factors led to Trump’s 2024 win, the president-elect’s appeal to key voting groups likely pushed him across the finish line in the states that mattered.

Well, this was a cash cow for the military industrial complex. The CIA was involved in the Golden Triangle heroin dealing, which we know was big. I mean, they used to stuff heroin in dead bodies of American soldiers. That was a CIA operation. And they used to bring them back here. That service CNN, in their quality days of real journalism, actually covered that. So, when we take a look at the cash cow represented by the Vietnam War, which was only one of five reasons, and I won't go into all of them here, but one of five reasons that John Kennedy was assassinated was because of his refusal to get involved in the Vietnam War. Also he refused to start a nuclear war with Russia over the Cuban missile crisis. Was he ever

right. If we landed the Marines on the beach in Cuba they would have been destroyed by tactical nuclear weapons that were already there, unknown to the Pentagon, They thought they were only ICBMs and it's just incredible.

One month before Kennedy was killed, the Diem brothers, who were ruling South Vietnam, were assassinated because they didn't want American troop involvement. And the CIA made-up their phony baloney excuse they released to the media and the “mockingbird” media ran with it. The New York Times, The Washington Post said. All those Diem brothers were corrupt. It was a good thing the CIA had them killed. They admitted it. But that's not why Kennedy and the Diem brothers agreed not to have American troops. Vietnam had just gone through a prolonged period of French colonization. Conquered by the Japanese. They did not want American soldiers except in an advisory capacity on their soil. But Kennedy didn't want any of it. He was willing to give arms and aid, but he wasn't willing to go further. Then look what happened. The Diem brothers are killed by the CIA. And a month later, John Kennedy is dead and National Security Memo 263 was reversed by Lyndon Johnson who is one of the biggest crooks and hedonistic persons to ever serve in the White House. And Johnson gave the military industrial complex their Vietnam. And the killing of Kennedy solved a lot of other problems too. When I learned about this, I said, this can't happen.

There was no term like “Deep State” when I discovered all of this. And I said we can't have a secret cabal running America. That was my words for it. In 1980, I read a book that really changed my perspective as well, written by my friend Pat Wood. I didn't know Pat at the time. I do now. He's been on my show dozens of times over the years and Pat detailed how our government was being controlled and manipulated by corporate interests. The book is called Trilaterals over Washington, and is still available. It's a great read even today.

So let's get to the point. **John Kennedy refused to play ball with the emerging deep state, which happened in 1947, when there was no such agency that was kept that secret. The NSA, the CIA and the Air Force were all born the same time. And they were basically designed to subvert political control of the United States away from the people and their elected offi-**

cial and diverted to intelligence agencies and to the control of the corporations, the major corporations, mostly connected to the military industrial complex. And then they would get their mockingbird media to reinforce their goals and desires. And they got Big Pharma to play along with them. I could go on and on and on, but it was the building of the Deep State empire that started really in 1947.

By the time 1960's came along, it was getting embedded. And Eisenhower warned us, he said, beware of the military industrial complex. Today, if he were alive, giving his farewell address that he did in 1960, as a farewell speech in 2024, he would say beware of the Deep State. But effectively, he'd be talking about the same thing. The early level of the Deep State is nowhere near as monstrous, convoluted, evil or as large as it is today. Today it predominates every phase of our lives. We have been invaded, we're in the process of being occupied and the election of Donald Trump gives us a foothold from which to fight against these interests. And they are Communist, and many of them are satanic and a Communist American has more in common with the Communist Party CCP Chinese than they do with American citizens.

They have nothing in common with us. The Nancy Pelosi's, Kamala Harris', none of these people have anything in common with us. They don't understand the struggles of putting food on the table, being able to afford a car repair bill, they understand nothing about that. And to get their way about Vietnam, I am going to just walk you through this. John Kennedy did not want nuclear proliferation. In May 1963 at his speech at American University, I think the greatest speech he ever made, he signed his death warrant and cemented it when he

said there will be no troops sent to Vietnam and National Security Member 263. He was killed six months after his speech at American University. And less than a month after National Security Memo 263, we got the Vietnam War. From the war we got 58,000 dead Americans and 4 million dead Vietnamese. And for what? War for profit, continuing the heroin trade and the Golden Triangle. And by the way, it was no different in Afghanistan, where we paid the Taliban to guard the poppy fields that we extracted under military control. And Pat Tillman, the NFL star who joined the military after 911, because of his duty to patriotism was murdered because he objected to what he was seeing. It's a fact.

Now, John Kennedy was killed. Martin Luther King became an anti-Vietnam activist. A lot of people only think he was working on civil rights and that was his main focus and he was excellent at it. But he would start speaking out against the Vietnam War. And it had racial overtones. Draft boards, primarily in the South, were drafting a disproportionate number of African Americans than they were white Americans. That's a fact. That's a fact but that doesn't make all whites racist. But it did make those draft boards racist. And Martin Luther King spoke out against it. He said, they're sure willing to send a black man off to die sooner than they would a white man. And he was correct in saying that. Well, let's go through the scenario. When he became anti-Vietnam, the day before King's assassinated, he was protected by 11 FBI agents. They were all removed from the case and he had no protection except really kind of an unofficial bodyguard. He walked out of his hotel room onto the balcony and was shot and killed the day after.

J Edgar Hoover, who has already been caught covering up the Kennedy assassination, he plotted the murder of Martin Luther King. As for Bobby Kennedy, and this is something I wonder if Bobby Junior's ever going to talk about, because I know for a fact that Bobby Kennedy was warned not to run for president. He was anti-Vietnam, power back to the people, really promoting the civil rights agenda to a new level. A good man who cared about a country. Well, when he secured the California nomination for president from the Democratic Party, which was the big feather in his cap, he was killed after he gave his acceptance speech. He was warned, and this is what I wonder if RFK Jr is ever going to talk about, if you Bobby Kenney run for President, and you reopen your brother's killing, you think that you're going to stop Vietnam, think again, Bobby Kennedy.
