### Analysis of the Alleged Killer of the UnitedHealth Insurance CEO

Admit, when I first heard the news of the killing of a large health insurance company CEO by a disgruntled man who suffered from debilitating back pain, I thought of my own case 10 years ago when I suffered from excruciating back pain from premature spinal stenosis that required me to deal with issues involving my own health insurance coverage. Fortunately, I was able to work out the issues with a successful surgery that ensued. But I often think, what would a person do if he or she had to indefinitely continue to endure the intense pain from a defective back because they could not get their health insurance company to approve the surgery?

Hello, this is Dr. Grande. Today I will offer an update on the case of Brian Thompson, including the arrest of Luigi Mangione.

Of course, there is no case that justifies murdering the president of a health insurance company because the company refused to pay for corrective surgery, whether the malady is life-threatening or not. But this case piqued my interest because I wanted to know what would make a young, attractive, highly intelligent, and well-educated person who allegedly suffered debilitating back pain kill the CEO of the largest health insurance company in the country. I was curious to find out what would motivate such a person to commit such a heinous crime.



Of course, no one knows all the reasons why the accused Luigi Mangione would kill the CEO Brian Thomson (assuming he did it). But we can try and find out. The following is a report by Dr. Todd Grande, a well-known licensed counselor who discusses true crime, pop culture and mental health issues on his YouTube program, of his findings in the Luigi Mangione case. I think you will find it interesting.

First, a look at the background of this case, a move to the timeline of the crime and offer my analysis. Luigi Nicolas Mangione was born on May 6th, 1998 and was raised in Towson, MD. His grandfather Nicholas, was a wealthy real estate developer who owned several valuable assets, including country clubs and retirement homes. Nicholas died in 2008 from complications of a stroke. In 2016, Luigi graduated from an elite private high school in Baltimore as the valedictorian. In 2020, he graduated from the University of Pennsylvania with both a bachelor's and a master's degree in computer science.

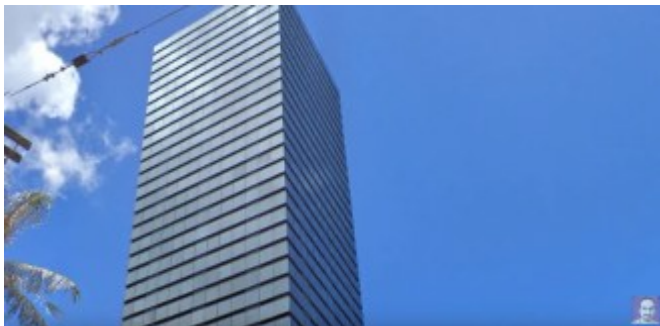

That same year he started working as a data engineer for TrueCar incorporated. This company is located in Santa Monica, California. In January 2022 Luigi joined a Co-living community in Honolulu Hawaii called Surf Break.



This community is described as an inclusive global network of adventurers, remote workers and mindful travelers. It is on the 40th floor of a high rise building.

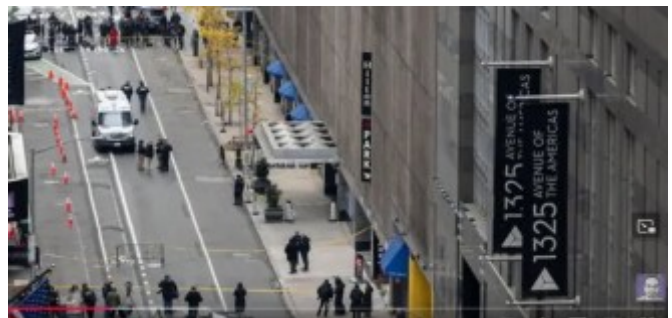
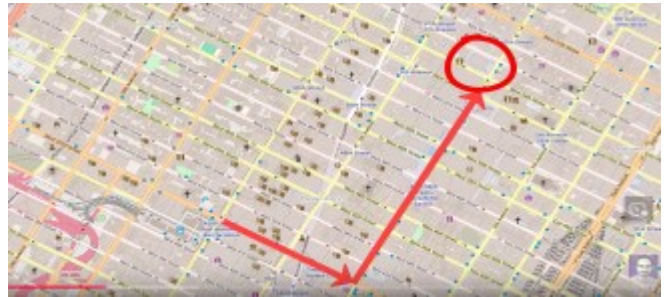


The rooms rent from \$1600 a month to \$3300 a month.

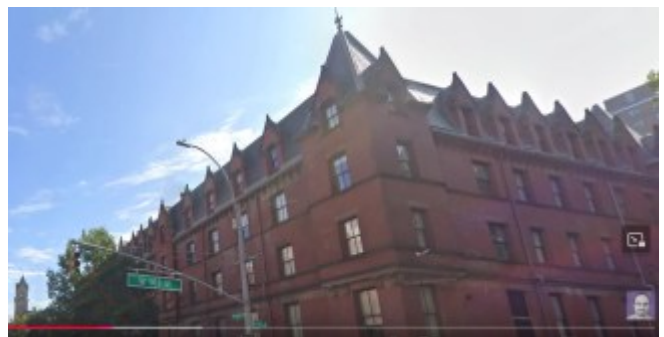


Luigi left the community in April 2022 due to pain from a chronic back condition called Spondylolithisis. Physical activity like surfing and hiking had aggravated his condition. Luigi returned to Hawaii in early 2023 and started a book club. In December 2023 he was cited for trespassing at a State Park. At some point, Luigi had back surgery and lost contact with his family. They reported him missing to the police on November 18, 2024.

Now moving to the timeline of the crime. According to law enforcement, here is the behavior Luigi allegedly engaged in. On November 24, 2024 Luigi took a bus to Manhattan and took a taxi to the New York Hilton Midtown, which is on the corner of W 54th St. and 6th Ave.



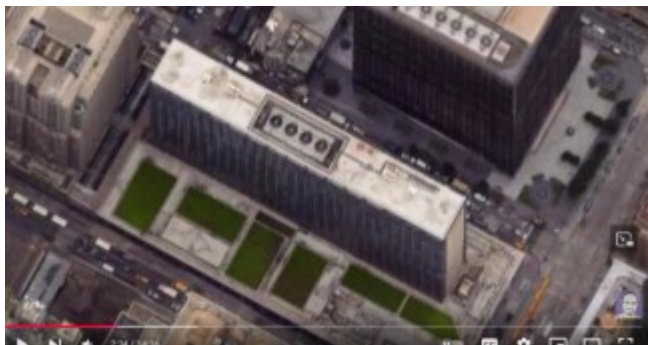
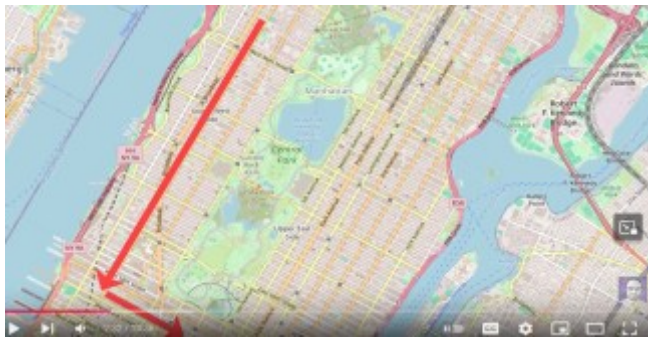
He then took a taxi to a hostel on the Upper West Side and checked in using a fake New Jersey identification.



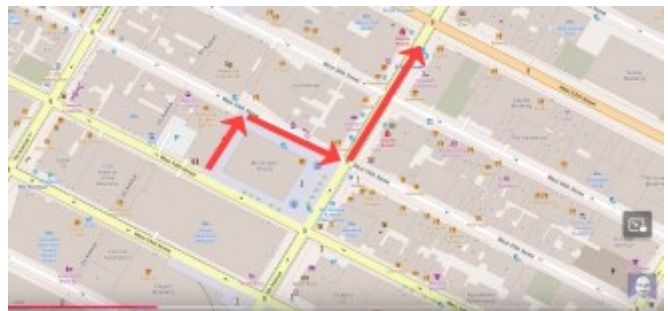
On December 4, 2024, Luigi left the hostel at about 5:30 AM and traveled back to the area of the Hilton Midtown.



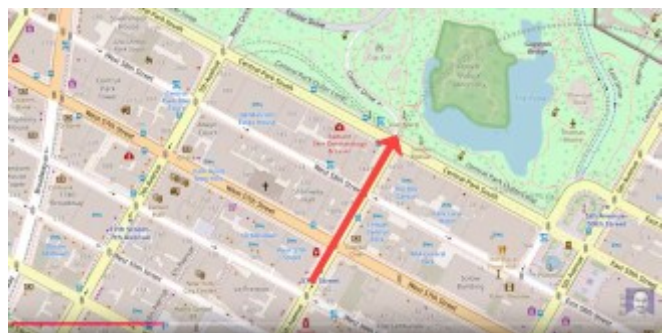

Bryan died after being struck in the back and leg. After the shooting, Luigi fled north on foot and climbed on an electric bicycle. He rode the bicycle into Central Park, then exited on the Upper West Side.



He visited a Starbucks before arriving at the Hilton at 6:39 AM. Luigi's intent was to kill the CEO of United Healthcare, Bryan Thompson.

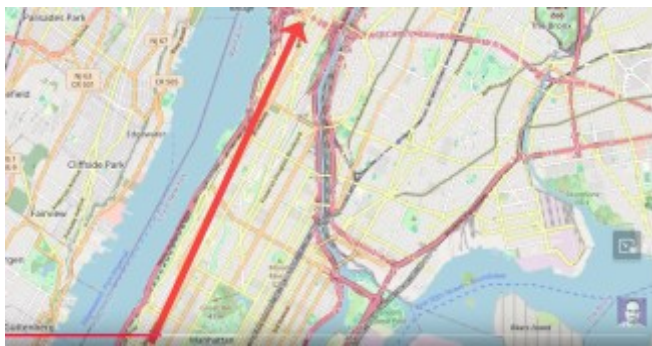


Brian was in Manhattan for a meeting that was to take place that day at the Hilton Midtown. Luigi had a 9mm pistol with a suppressor. On the cartridges he wrote the words deny, defend and oppose. This is similar to a phrase associated with insurance companies "Delay, Deny, Defend." At 6:45, Brian walked by Luigi's position on his way to Hilton Midtown. Luigi stepped out from behind the vehicle and shot Brian Thompson twice.

Luigi dumped the bicycle somewhere in that area and took a taxi to the George Washington Bridge bus station.



Five days later on December 9, 2024, Luigi Mangioni entered a McDonald's restaurant on Plank Road in Altoona, Pennsylvania.

He boarded a bus which was headed out of state.



This small town is 276 miles West of New York City. At 9:14 AM, an employee called the police after noticing that Luigi looked like the murder suspect featured in the images distributed by law enforcement. The police arrived at the scene and confronted Luigi, who was sitting at the back of the restaurant wearing a mask and looking at a laptop.

Investigators desperately tried to identify the killer. Initially they had no idea it was Luigi. The police distributed several different images of the killer, which had been captured during his time in New York City like from the hostel and in the Starbucks.

After he removed his mask, the police recognized him as the suspect.



Luigi produced a fake identification, bearing the name Mark Rosario.



When officers asked him if he had recently been to New York, Luigi began to shake. The police told Luigi that he was under official police investigation and lying about his identity would result in his arrest. At this point, he identified himself as Luigi Mangione. At 9:58 AM, Luigi was arrested. Some people complained McDonald's is too expensive, but for Luigi, the price was staggering. He definitely did not leave with a happy meal. I guess the only thing harder than dodging the authorities is resisting an Egg McMuffin. Luigi actually ordered a hash brown, but it came with a side of justice.

When the police searched the luggage and his backpack they found a few interesting items including a 3D printed 9mm semi automatic pistol, the same caliber used to kill Brian Thompson, a magazine containing several 9mm cartridges, they were full metal jacket just like the ones used in the murder,

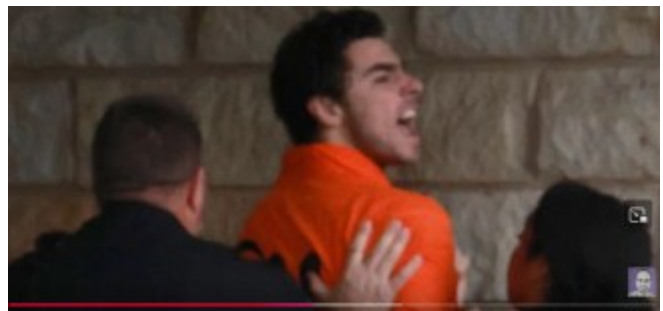
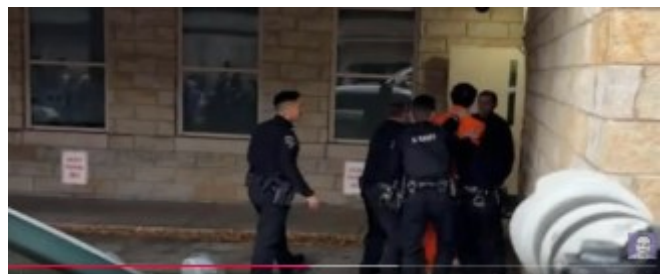


a 3D printed suppressor, multiple fake identification cards, and a US

passport. The fake ID that Luigi showed the police was the same one the killer used at the hostel in New York before the murder. The police also found a three page handwritten manifesto. Luigi refused to speak with the police in the state of Pennsylvania. He was charged with carrying a firearm without a license, forgery, possessing instruments of a crime, providing false identification to law enforcement and tampering with records or identification. Luigi was denied bail.



Not long after this, the state of New York charged Luigi in connection with the murder of Brian Thompson. He was charged with second degree murder, second degree possession of a forged instrument, third degree criminal possession of a weapon and two counts of second degree criminal possession of a weapon. In the state of New York second degree murder is similar to what other states designate as first degree murder. In order to be charged with first degree murder in New York, a crime must involve an aggravating factor, like killing a police officer or murder for hire. While being escorted to the extradition hearing on December 10, 2024, Luigi had a bit of an outburst and yelled something about an insult to the intelligence of the American people.



At the time of making this video, Luigi Mangioni maintains the presumption of innocence.

Now moving to my analysis. Here are my thoughts on a few areas

that stood out to me in this case. **Item number one**, Luigi's manifesto suggested that he was angry with the health care industry. He specifically mentioned United Healthcare, including how the company was massive and their profits were staggering. Luigi was critical of all health insurance companies for placing profit ahead of care. He said "these parasites had it coming. I do apologize for any strife and trauma, but it had to be done."

**Item number two**, Luigi occasionally posted messages on a literature focused social media site called Goodreads. He wrote a review for the manifesto written by Ted Kaczynski, who's also known as the Unabomber.



Here is a summary of Luigi's review. This is paraphrased. "It's easy to dismiss the manifesto as the writings of a person with mental illness. In order to avoid facing uncomfortable problems identified by the work, Ted Kaczynski correctly predicted many aspects of modern society. He was a violent individual who was rightfully imprisoned. However, that doesn't mean he was mentally ill. A more accurate characterization is that Ted was an extreme political revolutionary."

Luigi copied another review, which indicated that when all other forms of communication fail, violence is necessary to survive. Large companies don't care about the future and the term violence never solved anything is repeated by violent offenders and those who are afraid.

This brings me to **item number three**. Based on Luigi's review of Ted Kaczynski's manifesto, it seems pretty clear that he was a fan of Ted. There are a few similarities between the men. Both men were extremely intelligent. Ted had a PhD in mathematics and Luigi had a master's degree in computer science. Both men had a preference for unusual living conditions. Ted lived in a cabin in Montana. Luigi lived in a Co living community. Until the men were arrested for murder, they had no significant criminal history. And both men blamed certain trends in society for their own problems. Ted was worried about living peacefully in an era of technological expansion, and Luigi was angry that his back hurt even after medical treatment.

**Item number four**. Luigi had an interest in books about alternative medicine, psychedelics and recovering from chronic conditions. For example, he was interested in reading a book titled *Crooked, Outwitting The Back Pain Industry and Getting on the Road to Recovery*. And a book with the title *Why We Get Sick the hidden epidemic at the root of most chronic disease and how to fight it*. Not surprisingly,

many of those who promote alternative remedies also express a distrust for physicians and traditional healthcare methodology. In various social media posts, Luigi made it clear that he shared those views.

**Item number five**. Luigi's political beliefs were expressed in a few social media posts. He appeared to be displeased with both Republicans and Democrats. Donald Trump offended him because he refused to accept the results of the election. Luigi didn't like Joe Biden either because he refused to accept the effects of aging. He viewed both men as desperate to hold on to power. Robert F Kennedy Junior is who Luigi recommended.

**Item number six**. Running under the assumption that the state of New York charged the right man, what do I believe motivated Luigi Mangione to kill Brian Thompson?

This case is still in its early stages, so it's difficult to tell. People described Luigi as pretty normal. Not introverted or extroverted. He was friendly, productive and likeable. He was not described as socially awkward or isolated and never gave people the impression that he held extreme political views. Usually in a case like this, I would expect to hear about how the alleged perpetrator was creepy, aggressive, a loner, possessed dark fantasies, was fascinated with destruction, things like that. Luigi doesn't fit any of those descriptions. If he experienced some type of mental health episode, it must have had a rapid onset or he was very good about keeping the symptoms concealed. Furthermore, it is strange that the episode facilitated criminal behavior, but it did not dramatically diminish Luigi's organizational skills. He was able to develop and execute a complex plot which involved traveling to Manhattan and then escaping. It's worth considering, however, that Luigi did make several mistakes consistent with being disorganized, like keeping the weapon, ammunition and fake identification. He also wrote a manifesto which can function pretty well as a confession.

Another unusual aspect of this case is how Luigi appeared to have both personal and ideological motives. His chronic pain left him angry at physicians. But he also developed a wider hatred of the health care system. When people attempt to explain their problems, they can attribute the difficulty narrowly or broadly. On the narrow side, they describe specific circumstances that led to their difficulties, like being victimized by a person who is incompetent. An example would be a student who receives a failing grade on a math test because the teacher made a mistake when grading. If they look at the problem broadly, they focus on systemic issues like the inefficiency of government. Using the same example of the math test, the student received the failing grade because the school district was underfunded due to corruption and did not supply him with adequate study materials. Luigi appeared to be using a broad attribution. In his mind his difficulties were caused by a broken system. Furthermore, he rationalized being violent and allegedly carried out a murder. Luigi did not know Brian Thompson. Brian did not do anything to him personally. Rather, Luigi killed him to take down the system. He was looking to make a larger statement. Whether mental health symptoms contributed to this way of thinking is a mystery at this point.

Now moving to my final thoughts. It's possible that Luigi is going to use the defense based on mental health. It might be his only hope. If he does, he may want to consider the fate of his hero, Ted Kaczynski. Ted suffered from schizophrenia yet resisted any efforts to mount a defense based on insanity. He insisted that he was fine as far as his mental health. Ultimately, Ted pleaded guilty to all charges. This is an example of the no win scenario that mentally ill offenders sometimes face. If they say they are mentally ill, nobody believes them and they go to prison. If they deny having a mental illness, people may actually believe they are ill, but the end result is still prison. If Luigi is hoping that people side with him because he killed a controversial figure, he will be in for a disappointment. Many people view Luigi favorably, but that is not going to prevent him from taking a magical prison journey.

Those are my thoughts on the case of Luigi Mangione and Brian Thompson. Thank you so much for watching. Talk to you soon.

### End of Dr. Todd Grande's Article

At this time, here are my observations of the Thompson murder case.

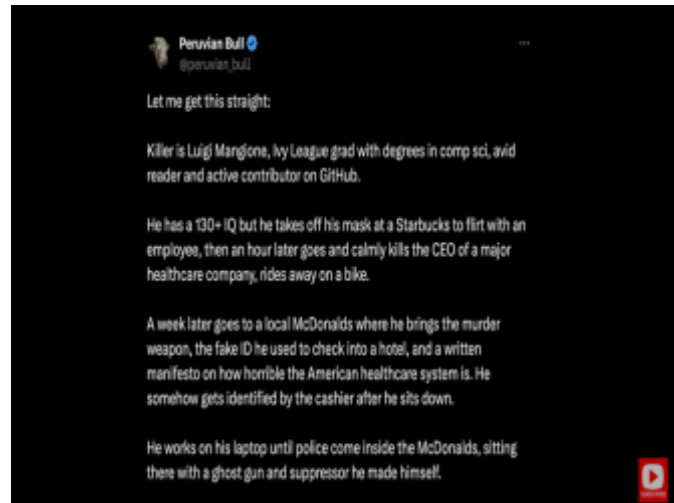
This blatant out-in-the-open public killing has definitely resulted in two very prominent backlashes within the American community.

**The first is the public's open outcry and criticism of the healthcare system and its failure to care for its clients.**



**The second is the growing public skepticism that Luigi Mangione is the actual killer and that he may just be a "fall guy."**

Here is a reaction that was seen 22 million times on X that typifies this skepticism



It is a bit surprising that Luigi Mangione, has received an outpouring of support and celebration, reflecting widespread disillusionment with the status quo and the perceived ineffectiveness of conventional politics in addressing problems. Alongside these mainstream reactions, extremists from disparate ideological communities seemingly have united in praising the suspect's alleged actions, perhaps in an effort to encourage further violence.

At the time of this writing Luigi Mangione was transferred to Manhattan for arraignment and trial.



On December 23, 2024 in the Manhattan Criminal Court Mangione pleaded not guilty to charges of murder, terrorism and other charges brought by state prosecutors in New York.

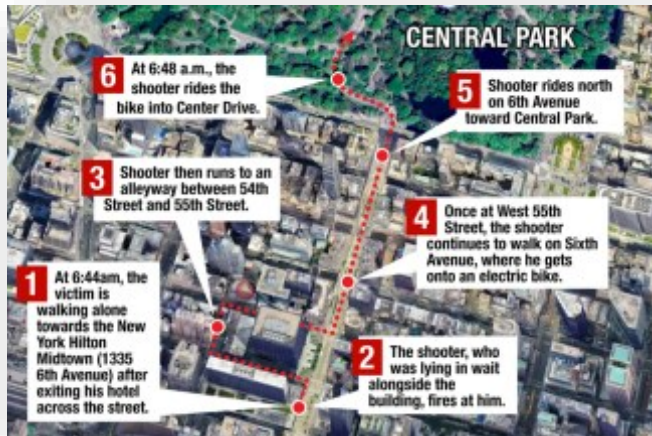
My analysis of Brian Thompon's background in the next article evokes added questions about why he was killed and who really did it.

The following is a summary by the *New York Post* of the shooting of Brian Thompson, the victim.



**B**rian Thompson, the CEO of insurance giant UnitedHealthcare, was gunned down Wednesday Dec 4 outside a luxury Midtown hotel in a “brazen, targeted attack,” police said.

Thompson was named CEO of UnitedHealth in April 2021. He joined the company in 2004. He was one of several senior executives at the company under investigation by the Department of Justice.

Thompson’s wife, Paulette, said her husband had been getting threats before he was killed.

Thompson’s shooting led to sick support online, and even spurred a tasteless lookalike competition in NYC.

A person of interest has been nabbed by police officers inside a McDonald’s in Altoona, Pa.

The suspect has been identified as Luigi Mangione, 26, originally from Towson, Md. He’s an Ivy League graduate who hated the medical community.

In order to convict someone of a crime you need to prove two things; an Actus Reus (Latin for guilty act) and Mens Rea (Latin for guilty mind). In other words you need to prove a person committed the acts of the crime and had the intent to commit the crime.

In the coming weeks and months the prosecutor of Philadelphia and later of New York must prove these two parts to convict Luigi Mangione of the murder of Brian Thompson, the CEO of United HealthCare Insurance Company.

So here are the two questions now facing the prosecution. (1) Did Mangione shoot the pistol that killed Thompson? And (2) Did Man-

gione have the intent to kill Thompson?

At first glance, it seems likely the prosecutor will be able to prove both elements. However, there are challenges involved in proving both of them, especially the second one involving having the intent or will to kill Thompson. Here are some observations I uncovered to support this.

Many commentators believe the shooter was not a professional, which according to the *New York Times*, fits the bill as far as experts are concerned. In their article, the Times talked to retired FBI agents and other experts and all of them believed that this wasn't the work of a professional because it's very risky to kill someone in Midtown, New York, and no professional will accept that kind of risk. So, as far as the mainstream media is concerned, this was just a one-man job from someone who hated Brian Thompson and wanted to send a message to the shady health insurance.

However, this mainstream media theory isn't one that everyone believes. We should note that despite his low profile,



Thompson has been in the limelight due to some serious legal troubles. The company United HealthCare Group, which owns United HealthCare Insurance, which Thompson is the CEO of, was rocked by a class action lawsuit earlier in 2024.



The mass legal action initiated by the city of Hollywood Firefighters Pension Fund became a particularly hot topic as it alleged a massive insider trading on the part of Thompson and other executives of United Health. According to records, the senior officers offloaded approximately 228,000 United HealthCare Shares. The three biggest

sales were executed by director Steven Hemsley, 121,515 shares on October 17th, 2023 and 66,081 on December 5th of the same year, for an estimated total of \$102 Million Dollars and Brian Thompson, 28,943 shares on February 16th, 2024 for an estimated total of \$15 Million Dollars. As you can see, Thompson was facing some very serious charges and was under a DOJ investigation. According to his wife, he had been receiving threats before he was shot. Coupled this with the fact that the assailant knew where exactly Mr. Thompson was going to be, and that he would definitely not have any private security with him.

It is also interesting that several hours after Thompson was shot and killed, someone called in a bomb threat to Thompson’s house, resulting in the police surrounding and entering the house and searching through the contents. We can only wonder what the police were looking for in the house. It should be noted that Thompson was living in a separate house from that of his wife and children, who have been living apart from him for several years.

Other relevant evidence was recently disclosed by commentator Dave Hodges who said that Nancy Pelosi had been working with Thompson on regulations involving stock futures. Apparently, the powers that be informed Thompson and Pelosi that “there will soon be a new sheriff in town,” presumably Trump, and that what Thompson and Pelosi were doing with stock futures was illegal and the new administration would, therefore, require Thompson to testify in Congress of what he was doing to avoid prison. This was part of a process to charge Pelosi for illegal stock trading in addition to a separate action against her for staging FBI informants at the Jan 6 riot.

All these things lead to a theory that Thompson was killed by people who did not want him to testify against them. There is an indication these people knew intimate details about Thompson and they helped the assailant in the crime. These people could have arranged for Luigi Mangioni to commit the crime or they could have used a professional hit person to kill Thompson and set up Mangione with the gun and a manifesto as a “patsy” ala Lee Harvey Oswald to be caught and take the fall for the crime.

Of course, these suspicions need to be fully proven by official investigation. But if they are true, this militates against the theory that a wealthy valedictorian and Ivy League graduate who was not a client of United HealthCare and was not turned down by the company for medical coverage, who had the money to get the best back surgery available to correct his alleged back problem, would have the “Mens Rea” of criminal intent to gun down Mr. Thompson in the middle of New York City because he was angry at the health insurance system.

Well, we will see what happens.

### Part 1, Drone Mass Hysteria



Hello, this is Doctor Grande. Today I will offer an update on the New Jersey drone scare, including a look at the potential role of mass hysteria and conspiratorial thinking. I will start with the background of this case, then move to my analysis.

Starting on November 18, 2024, people in New Jersey have reported large numbers of UFOs in the sky.

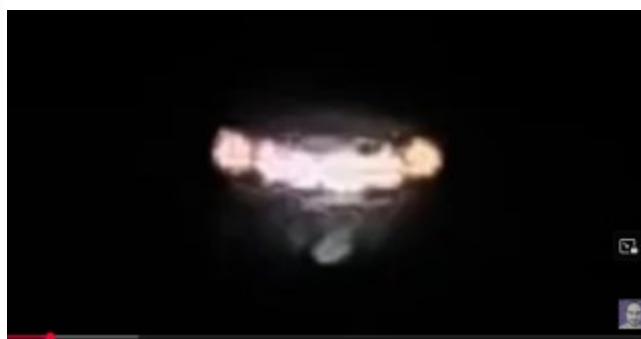


Many residents believe they are drones. Over the next few weeks there were thousands of sightings.



Most of the time, the UFOs were spotted between 6:00 PM and 11:00 PM when it was dark outside. Initially, the sightings were just in a few counties in New Jersey, but they expanded to many other counties and to other states, including Pennsylvania, New York, Delaware, Maryland, Virginia, New Hampshire, Connecticut, Massachusetts and Ohio. Some of the sightings have occurred over sensitive areas like reservoirs, power plants, police stations, residential neighborhoods, railroads, highways, military bases and bridges connecting New Jersey and New York. This last one is particularly concerning as New Jersey residents understand the importance of maintaining an escape route.

There have been a variety of reports about the characteristics of the UFOs. For example, the objects are as large as an SUV.



They are able to tolerate high winds, are associated with loud humming, have advanced and extended flight capabilities, for example flying for six to seven hours at a time. Some of the objects fly with their lights deactivated. In certain cases, the UFOs turn their lights off after being spotted, and some of the UFOs operate in a coordinated manner. Kind of like a conspiracy.

Many New Jersey residents have expressed concerns about the sightings and have demanded that politicians take action against the drone invasion. Some politicians share these concerns. There are those who suspected the drones were the work of foreign adversaries and were nefarious in nature. For example, House on Foreign Affairs Chair Mike McCall said some of the unidentified aircraft were spy drones from China.



He accused China of purchasing strategically placed farmland next to military installations.

Congresswoman Nancy May said she would not rule out the idea that the drones were from outer space, outside the universe, or from Iran or China.



The drones might be searching for a missing nuclear warhead. The outside the universe theory is curious. Is she talking about the multiverse? Maybe the drone scare is being caused by an overworked Marvel writer whose is fresh out of terrifying locations and thought to himself, what about New Jersey?

These weren't the only politicians troubled by the sightings. The former Governor of Maryland, Larry Hogan, posted a video on social media indicating there were dozens of large drones above his home. As it turns out, he may have spotted the constellation Orion, along with a few airplanes.



Some investigations by politicians resulted in findings which were not alarming. For example, Senator Andy Kim went on night time patrol with the police in Clinton Township, New Jersey and saw what appeared to be drones near the Round Valley Reservoir. Later, he said that most of the possible drone sightings were almost certainly planes.



On December 12, 2024, the National Security Communications advisor John Kirby downplayed any potential threats the drones may pose. He indicated that law enforcement had been unable to corroborate any of the visual sightings. The available imagery revealed that many of them were lawfully operated manned aircraft. There was no evidence of the drones sightings pose a national risk or a public safety threat. Also, they were not tied to foreign actors.



Two days later, on December 14, the Department of Defense issued a statement indicating there had been drones over military bases but they did not know who was operating them. Despite not knowing they were positive that other nations were not involved.

On December 16, 2024, John Kirby gave another statement. He said “we assess that the sightings to date include a combination of lawful commercial drones, hobbyist drones and law enforcement drones as well as manned fixed wing aircraft, helicopters and even stars that were mistakenly reported as drones. We have not identified anything anomalous or any national security or public safety risk over the civilian airspace in New Jersey or other states in the northeast “

The findings from four government agencies were released as well. The Department of Homeland Security, the FBI, the FAA and the Department of Defense. Essentially, the statements had the same thing, that John Kirby said. There's nothing to worry about. The FBI warned people in New Jersey to stop deploying lasers at objects in the sky and told them not to shoot into the sky with firearms.

Also on the same day, December 16th, president-elect Donald Trump declared that the government knows exactly who's responsible for the drones, and he demanded the information be released. He said something strange was going on, but he did not believe the enemy was behind the sightings.



Many New Jersey residents feel like their concerns are being dismissed by politicians. They are certain that the objects they are seeing in the sky are drones, and furthermore, these drones are part of some type of evil conspiracy. They continue to demand action from the government.

Now moving to my analysis. Here are my thoughts on a few areas that stood out to me in this case.

Item number one. At the time I'm making this video, the FBI has received over 5000 reports of drone sightings. Most of the sightings have been misidentifications of manned commercial and private aircraft. Some people have recommended that residents use flight tracking apps before sending a report to the authorities due to the high probability of any given UFO being an aircraft. There was a report of a drone crashing in the backyard of a private home in New Jersey. The police determined the drone was a toy. Despite all these false alarms, there was an arrest in Massachusetts. Two men were arrested after operating consumer grade drones near Logan International Airport.

Item number two. Whether there was a drone problem or not, there have been consequences to the New Jersey drone scare. For example, a medical evacuation helicopter was delayed due to reports of drones. The helicopter was transporting a seriously injured patient. And some people have reported mysterious flu like symptoms after learning about or seeing UFOs. For example, congestion, runny nose, coughing and puffy eyes. There have even been reports of increased tissue consumption. Ironically, if Amazon ever gets their Drone Delivery program working, tissues could be delivered very quickly to New Jersey residents using drones. Experts have indicated that these respiratory symptoms are probably due to respiratory illnesses, which are common this time of year. An alien drone invasion is an unlikely explanation.

Item number three. In considering all the new information which has become available since I made my first video on the New Jersey

drone scare, what could be happening here? Let's take a look at the various theories.

**Theory #1** is that foreign governments are operating the drones for some type of evil purpose. As I mentioned, there are a few politicians who believe that Iran or China could be involved.

**Theory #2** is that aliens have launched the drones. Just like the foreign government theory, the aliens are looking to cause problems. This is not a friendly mission.

**Theory #3** is the military is operating the drones. For example, perhaps they're testing some type of new stealth technology. Well, based on the thousands of reported sightings, maybe the technology needs a little bit more work.

**Theory #4** is that the increased number of sightings are the result of misidentification fueled by mass hysteria and conspiratorial thinking. Instead of giant drones sent by evil forces, people are actually seeing stars, airplanes and lawfully operated normal sized drones. When people started reporting UFOs, this led to increased interest and concern from the public. Which meant people paid more attention to the sky. Those New Jersey residents who were prone to mass hysteria or vulnerable to conspiracy theories, found themselves influenced by the increased sightings. When considering all the evidence in this case, which theory makes more sense to me. In my opinion, theory #4 is the most likely. The sightings came about through misidentification.

There could be a few drones which are being operated by pranksters or something like that, but for the most part people are seeing airplanes as hysteria and conspiratorial thinking have amplified the effects of the misidentifications. These are separate mechanisms which express differently in the scenario with the New Jersey UFOs. Mass hysteria is really about an emotional reaction to the perception of a potential threat. It is created by uncertainty and fear. Those affected by mass hysteria will focus on how the drones could cause physical or mental health symptoms. They will not necessarily worry about the drones being sent by aliens or foreign nations. No evil intent is required for the fear to spread. They may develop psychosomatic symptoms like congestion or a runny nose, which they believe are caused by the drones.

Social media is an engine for hysteria. A person doesn't need to directly observe UFOs to be affected. Just seeing stories about the scare on social media platforms is sufficient. Because mass hysteria is an emotional reaction, it tends to dissipate quickly. I would not expect the mass hysteria component of the New Jersey drone scare to stay around too long.

Conspiratorial thinking is quite a bit different. It is associated with illogical thought processes which try to impose order on chaotic or ambiguous situations. This is about finding a pattern where none

exists. A key component of conspiratorial thinking is paranoia. Conspiracy theorists believe that someone is out to get them. There are evil conspirators who are working diligently to cause destruction. Not surprisingly, with something like the New Jersey drone scare, conspiracy theorists will focus on the government and alien explanations. Furthermore, conspiracy theorists tend to believe there's a massive cover up involved. So they will accuse the government of withholding information. Unlike mass hysteria, which involves psychosomatic symptoms, conspiracy theorists don't actually have a concrete complaint based on suffering. They don't claim to be affected directly. Rather, it's about a hidden agenda. The worst is always yet to come. Disaster is always on the horizon. Conspiratorial thinking is a cognitive process, which means it is persistent. My guess is that conspiracy theorists will be talking about the New Jersey drone scare for many years to come.

Part of the problem with conspiratorial thinking is that everything which is observed supports conspiracy theory. There is no observation that leads conspiracy theorists away from the theory. Using the New Jersey drone scare, as an example, people have commented about the UFOs saying things like they are as numerous as the stars. The drones are the size of commercial airplanes. They look exactly like helicopters and they are flying near airports. Even after making statements like these, it never occurs to them that they may be seeing a star or manned aircraft.

One of my favorite examples is how somebody reported seeing the word frontier on the back of one of the UFOs as in Frontier Airlines. Instead of believing they saw an airplane, a conspiracy theorist in this situation, may take that same observation and believe it is proof that aliens took over Frontier Airlines. Nothing screams alien conspiracy quite like discount airfare and complimentary pretzels.

Now moving to my final thoughts. Over the next several years, I imagine that the use of drones is only going to increase dramatically. For example, Amazon is testing drones to make deliveries. This is called their prime air program. In one area of Texas, where they ran tests, people complain the drones sounded like a giant hive of bees. Considering how New Jersey residents have reacted to stars and aircraft and a small number of normal drones, presumably things will get much worse as drone activity expands.

That is my update on the New Jersey drone scare. Thank you so much for watching. I'll talk to you soon.

One thing that I've mentioned many times when I cover conspiracy theories is that how conspiracy theorists, when they're talking about aliens, always believe the aliens are up to no good. Like what the New Jersey drone scare, the aliens are trying to steal radioactive material, they're trying to capture military technology, which makes little sense, the aliens would clearly be more advanced. They are surveying farmland. They're checking out neighborhoods. Again, it makes no sense why they would do that. But they're doing all these things and the purposes are evil, right? In the conspiracy theorist way of thinking the purposes are evil. The aliens are looking to do bad things. Maybe they're preparing for some type of invasion so

they send the drones down, they look around for some reason they target New Jersey as where they want to be and they prepare this massive invasion based on the information they collect from these drones. They have the technology to cross the Galaxy, but they can't figure out how to hide the drones in the atmosphere so they're still working out some of the bugs with their technological progress. It's worth considering for those who are going to invest in these conspiracy theories anyway, that the aliens may have good intentions. Or maybe they're really neutral, like maybe the New Jersey drone scare is a reality show for aliens. Like they send these drones to New Jersey and they have fun watching people running and screaming in the streets. So all the aliens are huddled by the TV at 8:00 PM when the New Jersey Drone Scare Reality show comes on. And they get a kick out of seeing these drones fly over and people video recording them, things like that. So it's not nice, but it's not an evil conspiracy. They just want to have some fun. It's a reality TV show, yet another one based in New Jersey. Now, of course, this type of conspiracy theory is not as frightening as most of them. So it's not going to catch on. But again, if somebody's prone to believe in these things anyway, why not believe in something a little more light hearted. Maybe the whole drone scare came about due to an idea from a creative Alien TV producer.

For the most part, I agree with Dr. Grande that the many sightings of these drones result from a heightened awareness of drones flying around rather than an increase in drone activity. The drones may have been there long, but no one was paying attention. 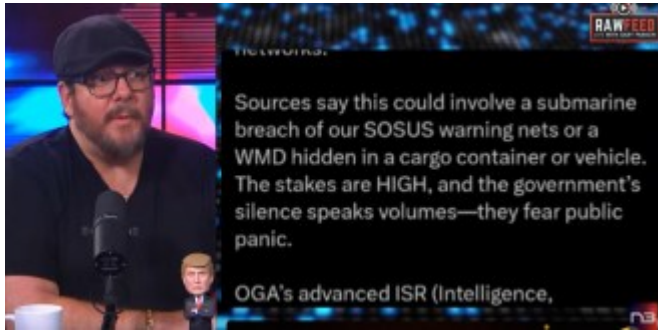

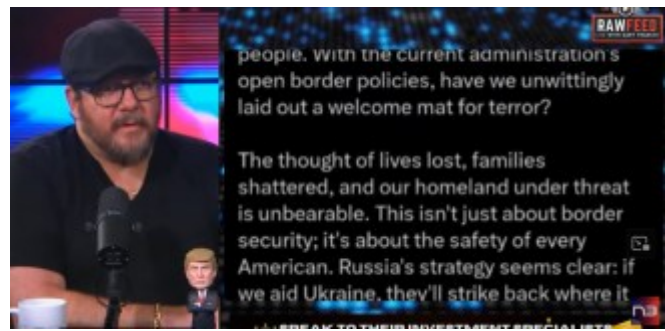

So whatever different temperature it creates an image. Gas usually leaks so slow that it goes quickly into ambient you know, before you can even see it. So we have special sensors that can detect gas leaks. We also have special sensors that can detect radioactive material.

So, with this gentleman that I had spoken with who was trying to raise the alarm to try to get somebody in the government to say, hey, we need to work together to go try to find this nuclear warhead, none of that ever happened. They knew that warhead was on its way to the United States. That's all that ever came of it. Nothing ever happened. 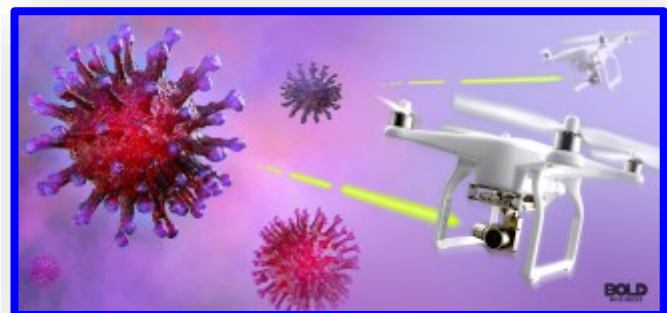

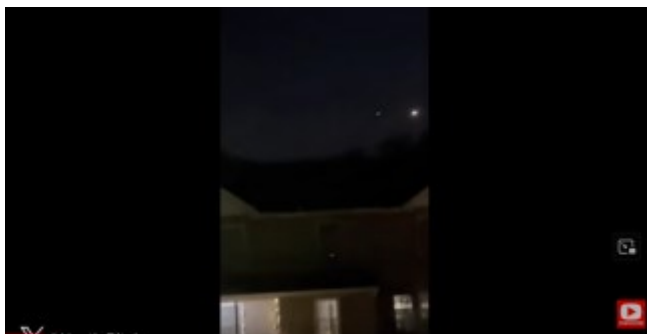


**Witness:** They weren't like the normal, you know, drone that someone would purchase and use in their home. They were large, some as large as a SUV.



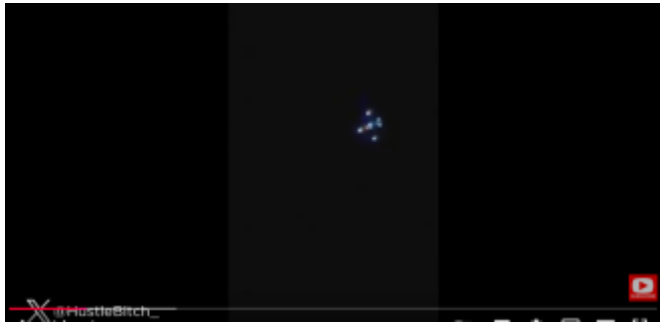
**Ronald Reagan:** I occasionally think how quickly our differences worldwide would vanish if we were facing an alien threat from outside this world.

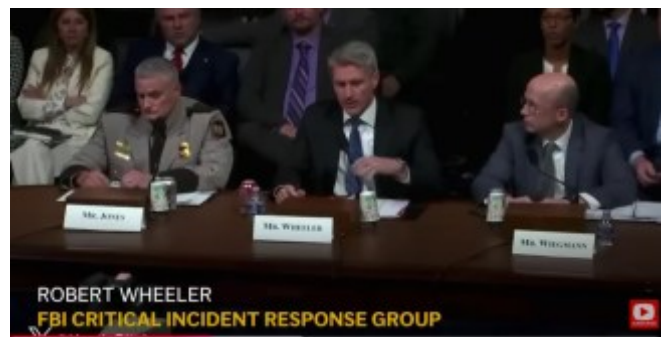
**Reporter:** People are very concerned about this. What's the White House message to the people out there who are frustrated that there isn't information right now?

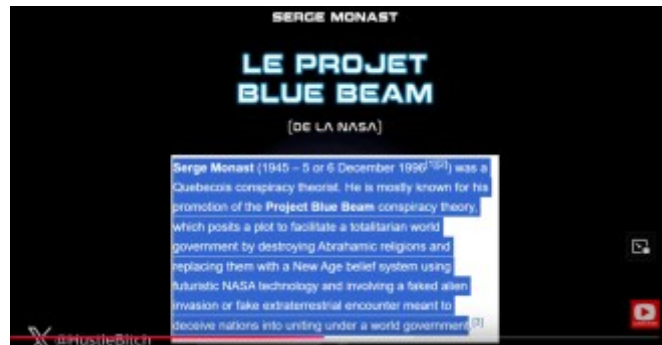

**Wheeler:** There's nothing that is known that would lead me to say that, but we just don't know. And that's the concerning part.

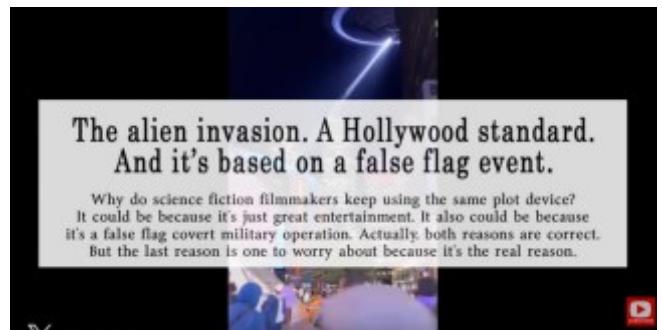

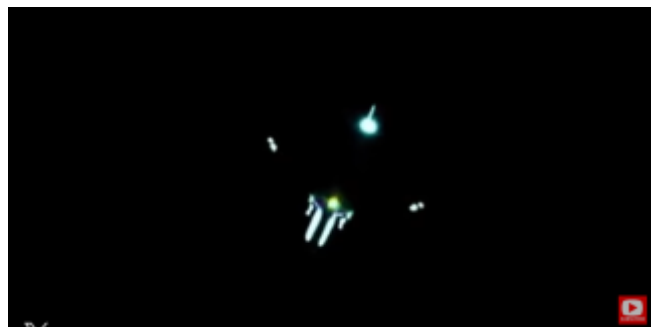
He also nearly lost his life because of his policies. Now, why do I think that these drones are not alien crafts?

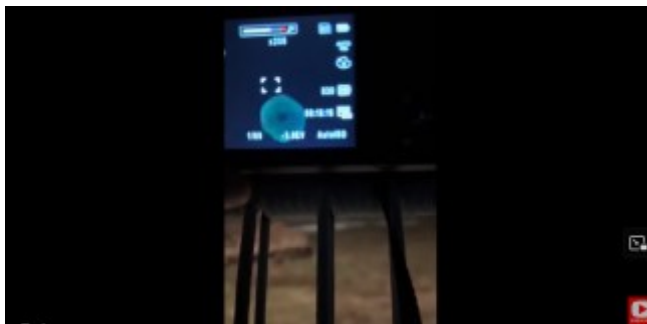

**Videofilmer:** Check this thing out. I tried to zoom in on camera all the way up to the door. This is what I get. There is round like shield around it.

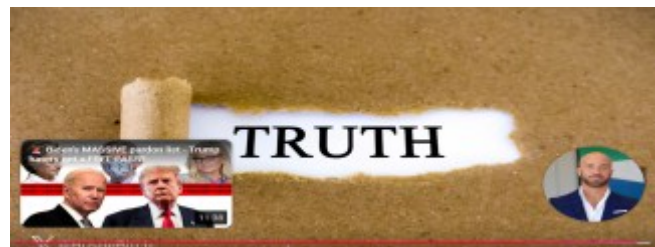

**Moore:** What do they want in this situation where they would want to start taking down aircraft? What do you know from your experience in the FBI that this deep state, what do they want?

**DeSouza:** The end goal is and this is a long term psychological operation as well as physical operation as well, the long term goal is ultimately to put together this grand operation called fake alien invasion.

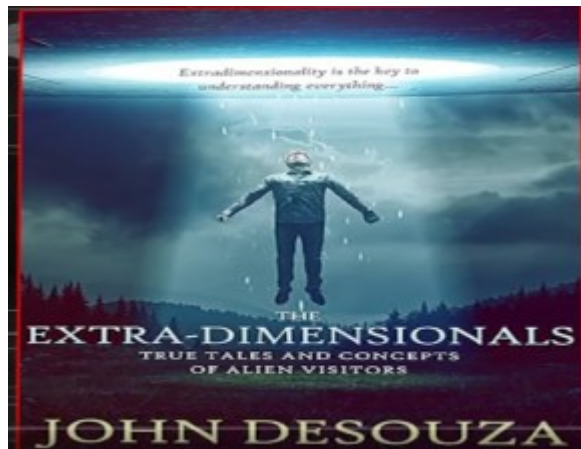


Now the only fake part about it is going to be that the alien visitors are involved with this. They're not at all. Everything else is going to be real. The destruction that they bring to our cities is going to be real.

#### Return to the Current Interview

**Moore:** Well John DeSouza is back. Former FBI agent who is really in charge of what became known as the X Files more famously, when he worked at the FBI and he's been warning us about this deep state program for a long time and he is back. John, great to see you. I mean, hate to say, but do you feel vindicated? You were saying, and I think it's interesting when that interview posted people like this is crazy, and now we're seeing it. It's not so crazy anymore, is it?

**DeSouza:** No, no. Clayton and thank you for having me on again. This is a great privilege for me to be back with your audience that are people who are extremely sophisticated in these areas and that's always a breath of fresh air because, you know, we always speak to people all across the country. And so many of them are asleep and they're just like, oh, there's drones up. What? What's happening now? What's going on? So it's really good to be here with you and I'm very relieved. Yes, it's great to see all of my predictions from my book, the Extra Dimensional see it all come to fruition and see it all come true.



But it's also very, very sad at the same time, because we're headed to a mass casualty event is what we're heading to.

**Moore:** A mass casualty event. We just saw this morning New Jersey has now banned drones over the airspace. That just happened just a short time ago. So they're trying to lock down the airspace. I can't believe it, you know, it took them that long to do that. But we believe we're heading for some sort of a large scale destruction event. Can you elaborate on that?

**DeSouza:** Yeah, well, first of all, I'd like to say good luck to New Jersey in closing their airspace to these, I'm calling them LSD large super weapon drones. That's a perfect name for them. Large super weapon drone because it immediately states what these things are



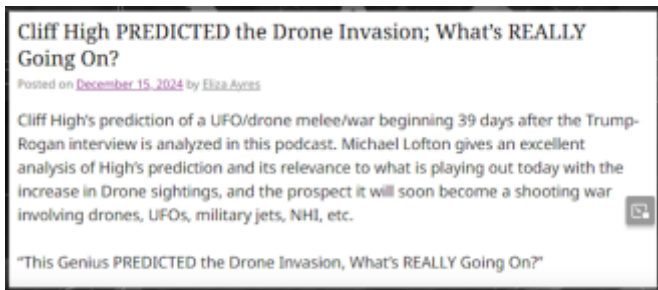

So I think everyone should start calling them LSDs as well. That might help the situation somewhat. So like I said, I don't think New Jersey's going to be able to keep them out of the airspace because of their qualities, their abilities. We've had jets try to try to track them down. They have the ability to put out electromagnetic pulses to deactivate any drones or even airplanes that go against them. They have the ability to disappear at 3000 miles an hour. It's incredible the abilities that these things have.

**Moore:** And these are a Deep State program? Is it your contention that these are an off the book Deep State program, an advanced aerospace technology that the United States government has and is deploying or not?

**DeSouza:** No, no, It's not the United States at all. The United States, the Biden administration is obeying the people who are sending these drones. They are by standing down our forces. They had to actively tell the military to stand down, no matter what they see in the skies and not shoot at these things. So the United States is implicated in this of course, but it's not them as the source of the drones or the plasmas and the orbs that are accompanying these drones either. So there's just a tremendous amount involved in this. But, I really wanted to start by telling you, Clayton, all the prophecies and predictions that have led us to this point right now, because the people have to be educated on what is going on so that they can know how to respond. They can believe also. So I wanted to tell you guys first of all that we have a prediction from Cliff High. And it's called the alien invasion prediction.



And it went like this. I'm sure your audience knows about this, you know. Little bits here and there, but I want to tell them about it.

**Moore:** Yeah, our audience is smart. I would say maybe 80% of our audience is awake. And so to the 20 to the 20% of you there that are fighting it, buckle up.

**DeSouza:** Well, the first prediction was from Cliff High its called the Alien invasion prediction. In 2009 he used his Webbot software to predict that president would eventually have an interview with Joe Rogan and that this would occur as a starting point for a countdown when it did occur. It did occur, and at the time he made this prediction Joe Rogan was not even very famous at that time.

**Moore:** What year was this again?

**DeSouza:** This was in 2009, so President Trump was not even anywhere near office at that time. So it's an extraordinary prediction because it was in 2009. And he said that moment that interview happened and how he knew that interview would be important, nobody knows. But through the Webbot software is how he finds these things out. And he said 39 days after the trigger event, which was the interview there would be on December 3rd, there would be UFO wars in the sky. There would be UFOs, wars in the sky. Now High does not predict events he predicts what people will be saying about the events.

**Moore:** Sort of chatter sort of online forums and chatter and that's how his web bot software was working.

**DeSouza:** Yes, and it crawls all these things and it sucks up the predictions from the language that people use because his contention is that people are all intuitive, much more than know, they're already saying what's going to happen in the future without even knowing it. And it worked because he had predicted 39 days after that interview which was December 3rd just a little while ago. So he missed it by a couple of weeks. I don't think anybody has any qualms with that. But it still started shortly after December 3rd 2024. So that was an extraordinary prediction. And that's just the first one that relates to this. Now also I wanted to say to you guys that in the Bible, in Thesalonians we have a prediction of an unfulfilled prophecy that says that God shall send upon them a strong delusion so that they should believe a lie. And we had no less a personage than the great Chuck Missler, who was one of the greatest Christian scholars who ever lived. And he always said that that passage had to do with a staged alien event. So that was his feeling and I always followed him on that.

**Moore:** Do you think that that's what this is right now? Is it the large scale staged alien invasion? I mean, we have people all over the country seeing these things, videos being shared every night that these are not airplanes, you know, and some are airplanes, right?

**DeSouza:** Yeah.

**Moore:** But some are these massive drones that are accelerating at speeds we don't have anything that can do. Physics. You know, otherwise it would tear apart a human being if they were inside a craft like that. Do you believe that this is the event?

**DeSouza:** Yes, I do. As a matter of fact, that goes into the next prediction that I wanted to talk to people about, which is about Werner von Braun, who was the head of NASA. I think he was the first one way back in the 40s. He died in 1977. But in the 1970s, before he predicted that world cabal would need to have several worldwide conflicts to control the nations. He said the first one that he wanted to put into the prediction was the height of communism against the free world. Communism against the free world and that would be a worldwide conflict. He was talking about the Cold War that came later. Then he also said when that peters out, there would be a war

between the Islamic world and the Western world, and that came true in the war on terrorism. But then he said the last prediction, it used to be called the last Trump card, but he said that the world powers, the cabal, the Illuminati, who control all the nations, he said their last card when their backs are up against the wall and they don't know what else to do would be a staged alien invasion. That's how he put it. In 1970s he told his protege Carol Rossin that this would occur and it was said it would be a fake UFO threat from outer space. He said it would be then a build up of military forces. The global weapons complex that we have. The military industrial complex that we have would take this wonderful excuse to build up their weaponry all over all over the world. And then the staged alien false flag event would occur. And that's what he predicted. And he said this would be used to unify the entire world behind the elites behind the cabal that's working on this.

**Moore:** Well, we know that they wanted one world government, so this is not a conspiracy theory at all. Just look at the documents at the 2030 Agenda, look at the World Economic Forum's documents. This is not a conspiracy theory. They put it in their own documents and they outline in their own documents that it needs a massive Pearl Harbor style event in order to be enacted. Again this isn't a conspiracy. It's in their freaking documents. I know there are people out there saying that's just conspiracy theories. You know, as we say on this show, conspiracy theories are just six month spoiler alerts. And we've seen that repeatedly now. So as a mass casualty event, I want to circle back to something you said at the outset. Where does that come into play? Is it being used as sort of a catalyst, or who is going to carry out a mass casualty event in your estimation? What do you think that will look like?

**DeSouza:** Well, it could be what we call a slow kill situation. Slow kill, which really means it would be mass casualty event stretched out over long periods of time. So because as we found out during the last pandemic if you kill people slowly on a large scale, then for the most part people don't notice. They don't notice it and they have many industries helping them, like the medical industry and others helping them to put up excuses that this isn't because of this particular purpose. It's because of something else.

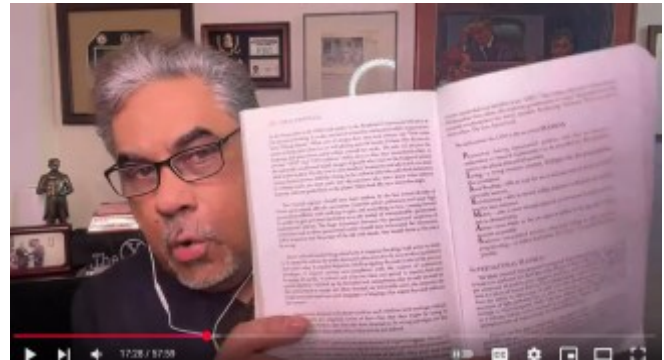
**Moore:** Right.

**DeSouza:** So for that reason, this mass casualty event that I'm talking about may not be an all at once type event that is super dramatic so that everyone will be able to say, hey, wait, look at that, what happened? What if it's a slow kill situation where they use what we call dirty radiation, dirty radiation type bombs to you know, slowly spread this radiation. And let me just tell people how I get my information and the necessity of corroborating my information with a lot of different sources. I am involved in a network of many former and current officials in the national security structure. The intelligence structure which means various different agencies, not just the FBI, but many, many other various agencies. And what we do is we share rumors. We share rumors and raw data. People who have not been in the intelligence structure don't know that a simple rumor can save many people's lives if it is correctly placed and correctly given to someone, and that we've seen that many, many times because like right now where all you are rumors and raw data you

have to place that and reinforce that and take those rumors and corroborate them with many other sources. That's how we share information because that way we can never get into any trouble for sharing any top secret information.

**The remainder of the interview is presented here in an abbreviated format to save time.**

**DeSouza:** So here are my other predictions in my book.

**Moore:** Holy Smokes, that is what we are now seeing over the past few days in the media they are calling them plasmas.

**DeSouza:** Yes, I gave all through my book Extra-Dimensionals, the reasons why we need to call these things plasmas because of the light they give off, we could hardly see the metallic body of these things. And I explained in detail why they should be called that.

The cabal copied my book on the names of plasmas.

Plasma is my acronym for UFO. It means

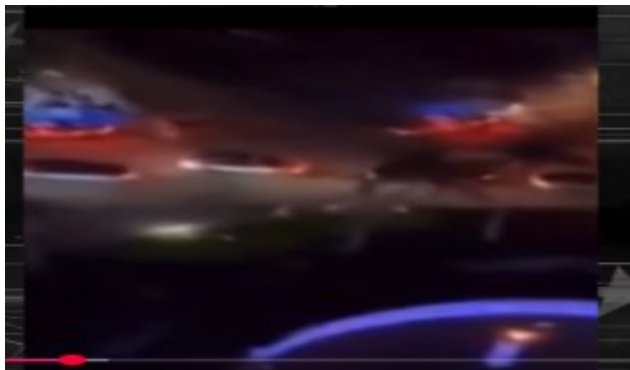
The replacement for UFO is the acronym **PLASMAS**:

- Paranormal**—having supernatural qualities such that no terrestrial explanation or natural explanation can be provided for this particular craft in the physical/material iteration
- Living**—a living creature, sentient, intelligent but also

- programmable like a computer
- Aura-Reading**—able to read the auras and emotions of living creatures, especially humans
- Soul-Printing**—able to record, collect and store a blueprint of a human soul for later reference
- Mobile**—able to move through physical or non-physical media and even able to dematerialize
- Aerial**—most likely in the air when it wishes to be seen by as many humans as possible
- Scanners**—unoccupied scanners constantly roving to carry out their programming—to collect soul-prints of as many “interested” humans as possible

The real genuine UFO’s are actually alive and are conscious.

The central theses of my book Extra-Dimensionals is that alien visitors and UFOs are not physical and that leads directly into the notion that if someone says they found UFOs it would be a lie because UFO’s are not physical. They can maintain physicality for short periods of time. We saw this in the Miami Mall incident two years ago where we saw these alien creatures come through this portal and went through the mall in Miami and created this hysteria and fear causing people to shoot at them. They were observed by people and the police and then they disappeared because they can’t hold that physicality for very long.



So this global cabal is trying to impose some sort of martial law or one world government in place of the United States We know if the president is removed from power, NORAD becomes the de facto authority under the guise of continuity of government.

The US is working with the cabal and one of the great goals of the cabal is to stop the inauguration of president Donald Trump. They feel very strongly about that.

That is why we are seeing all of these drones. I would like for people to look at a map of the upper half of the east coast of the US around New Jersey.

The drones are showing up all over the world, not only in the US. This is a global operation. Even Werner Von Braun did not predict the scope of this operation.



But there seems to be a saturation point around New Jersey for some reason. And why is that.

New Jersey is central to many other states that are controlled by the cabal and that have gun control and that will not be shooting at these drones. That’s one of their major concerns.



And the bottom of all these states is Washington DC and I believe Washington DC is the ultimate goal for the cabal.

**DeSouza:** Just look at the statement of the Biden administration the other day by John Kirby.

He said to the effect that we have very carefully examined this and our assessment of these drones are they are fully legal and lawful and pose no national security threat or public safety threat or have a foreign nexus.



It seems the main fear Kirby had was people shooting at these drones. He inferred you would be arrested for shooting at these drones. But his real fear could be that, if someone were to shoot a drone down (before their mission is accomplished), much radiation could be released.

Many stories are being circulated for the drones such as there is missing radioactive supplies being searched for or there is a missing nuclear warhead from Ukraine being located. These stories have circulated years before. They are being used again to justify the drones.

We know these stories are not true because our intelligence agencies are tasked with special teams to locate and secure any nuclear weapon not accounted for and none of these teams have been activated to do that.

**Moore:** I can confirm what John is saying here from multiple whistleblowers I have spoken with who have been involved with working on these crafts and working on these projects. Many of them were part of the US military and they were treated like garbage by their cabal supervisors. So what can we do about this? How can we call BS on all of this?

**DeSouza:** Oh, absolutely, Here is the question you always have based on motivation. You always ask why? Why is the Deep State Cabal doing this?

My answer is by way of a 2002 movie called Star Wars Episode 2 The Attack of the Clones. The whole point of the movie was to show how Senator Palpatine in the movie is trying to become the Emperor, has been trying to develop a giant army of clones to serve the republic and there is a scene where he tries to reveal his army of clones and other side was thinking it was about 1000 clones, and he shows he has 100,000 of these clones and he says they all serve me personally, and that is why I am going to be the Emperor. ## Harry Dent's Opinion going into 2025

**O**ne financial advisor I closely follow is Harry Dent. He is a Harvard MBA, Fortune 100 consultant, bestselling author, and founder of Dent Research.

Dent accurately predicted Japan's collapse in 1989, the dot-com bubble-bust in 2000 and the housing bust in 2006 to 2007. He has appeared on Good Morning America and PBS, and is a regular guest on CNBC and Fox Business and has been featured in Barron's, Investor's Business Daily, Business Week, The Wall Street Journal, and American Demographics.

Going into this new year under the new Trump administration, some of Dent's clients asked a few pertinent questions that I want to share with you. Over the years, Dent has been uncannily accurate in his prognostications.

Client Question: Now that we know President Trump is elected for another 4 year what will be the impact on our economy and the possibility of a recession?

**Dent: Biggest impact will be a recession to the degree he is successful in implementing mass deportations. That is a direct hit to GDP. Same with cutting government wasteful spending, with a loss of jobs as well. Also, fewer lower wage workers could create slightly higher inflation. Cutting taxes will increase an already runaway government deficit since 2001. None of this is good short term. Cutting government waste is good longer term. Cutting taxes is only good if we cut expenses commensurate.**

Client Question: What do you see as a strong economy other than the Markets? I don't see any strength, I only see the rest of the world slowing rapidly. What are the strengths and what are we looking for to get back into the Markets? Still feels like nothing has improved.

**Dent: The whole developed world is peaking and slowing starting with Japan in the 1990s. The massive stimulus has lifted global financial markets 2 - 3 times where they would be in normal times, and is the main reason for the wealth effect. You're right. This can't last and a major financial crisis will be hard to recover from due to the flat to declining demographic trends in the developed world. I don't think we will see stock or real estate prices this high again for the rest of our lifetimes in the western world or East Asia.**

Client Question: Crypto over \$91,500, DJIA hovering around 44,200 and 10 yr Treas at 4.445%, when the hell does this insanity begin the long slog back down the mountain towards reality???

Seems like the Pied Piper of the Massive Correction long overdue is leading 1,000,000s of our countrymen and women to a cliff of never-recover.

What are the 3 most important keys to understanding and gauging the ultimate Crash, so we set the stage for our client families and their having the highest probability of growing money in the recovery with the greatest degree of confidence? And in the meantime we keep them safe.

**Dent: Unfortunately, investors are now 100% convinced the Fed and central banks won't let the economy or stocks fail for long... hence, little downside risk. So, everyone's buying on dips if they can.**

**This is simply what I call a "go until you blow" scenario. The markets keep looking like they are topping, but keep edging up. It will finally blow when there is no more net new money to come in...**

**Then it switches to a crash that feeds on more and more investors getting back to reality and selling more and more until that is exhausted. Greater the bubble, greater the crash!**

**The markets do look very topy again... but my biggest concern is that the Bitcoin/crypto cycle still has until late 2025 until it naturally peaks on its 4-year cycle. However, its surge has started a year early, and that could leave more time to turn a 3rd 4-year cycle into a larger-wave 1-wave up that takes 2 years to bottom on this 4-year cycle instead of 1 year, i.e., 2025 to 2026+. That would make a nice larger 2-wave cycle down into late 2026+.**

**This is the trickiest and most extended topping process I have ever seen. That's what happens after \$27T+ in stimulus over 16 years and still going - total perversion! The monetary stimulus has been reversed a bit, but the larger fiscal deficit side is still full throttle.**

**So, go until it blows it is. Have a quick trigger if you play the late stage upside here. Later 2025 is the longest I could see this going, but it can blow any time at this point, and likely sooner than later. I think January will be key as it tends to be a harbinger for the rest of the year. Is 2025 the last bubble surge, or the first dramatic crash wave of 50%+? I think the crash scenario is more likely.**

**As long as Bitcoin keeps rising, you can feel better about playing stock upside near term. I would be more cautious about Bitcoin and crypto here as it could re-**

**verse fast and hard first. The trendline resistance through the past highs for Bitcoin is around \$106,000 just ahead. That would be a good time to sell Bitcoin and crypto and stocks as well.**

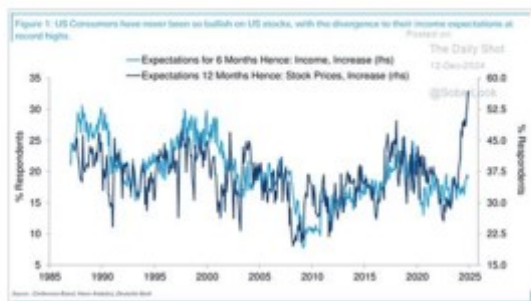

But many major corrections like 1987 or 2000-02 come merely from overvaluation of stocks from this tendency towards over optimism even in ongoing economic expansions. This crash will come from very high valuations and the likely end of the \$27T stimulus bonanza since 2008. Hence, look out below!

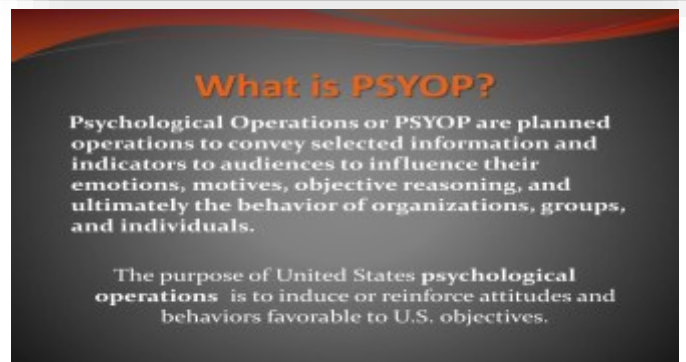
#### US Consumers More Bullish Than Ever on Stocks: Not a Good Sign!

**Newman:** Thank you again, Stephen. There is absolutely truth to that warning. If I were one of Donald Trump's nominees, if I was not a Deep State operative, I would be very, very concerned for my personal safety, for my personal security and also for your reputation. We saw this during the first term. **Newman:** Joe Rogan played a huge role in this election and Joe Rogan is just kind of the tip of the spear. But what has happened here is all of these people who wouldn't watch CNN or MSNBC or even Fox, or Newsmax, if you paid them, they would rather listen to podcasts. Now they're getting direct access to what the President is saying. So they may have heard, you know, when they went to Thanksgiving dinner that Trump is a Nazi. But then they heard him on the Joe Rogan podcast and said wait, that doesn't sound like a Nazi. What do you mean right? So what has happened here is that, well when I went to journalism school, Stephen, they always emphasize, and this was like 15 years ago, you guys are the gatekeepers. And especially for the younger generation. Yes, some of the older folks, they still tune into their cable TV or whatever, but the younger generation they're now going to podcast. They're now going to these smaller venues that they trust and so this is really a revolution in how politics is done. It's a revolution in the way Americans receive, consume, and even put out information. And I don't think they're ever going to be able to try to put this back. They're still scrambling. You know, the UN just announced a couple weeks ago in partnership with the crazy regime in Brazil and new censorship program where they're gonna try to silence climate misinformation. That they're living in the past. It's not going to happen unless they shut down the Internet completely. They are not going to be able to regain their position of dominance and I think that's a very good thing, frankly, Stephen.

**Gardner:** Yeah, I think the power of the podcast is that you get to humanize somebody. They get to develop a story or a thought or a concept, or you know some political activity that they want to put into place. They also have a chance to defend themselves and I think that was one of the things that Kamala Harris did very wrong is she would pick these sometimes paid for podcast to just give her softball answers. And then she couldn't even articulate a good answer to the easiest most soft, I mean, it wasn't even softball. It was T-ball, but all was right there. You just have to hit it off of the Tee and she couldn't do it. And meanwhile, Trump was going on young people's podcasts, older people's podcasts, people that used to be, you know, far left that are now more conservative and people got to really see, OK, who is this guy. He loves music, he loves golf, he loves business, he loves America, he loves his family. He thinks that there's two genders. He has no problem with gays, but he doesn't want men and women's bathrooms or women's sport, like it just became very crystal clear who this guy really was. Meanwhile, you watch Fox

News or CNN or MSNBC, and you get these little pithy, quick response answers from guests. You don't ever get a real picture. I just think that the power of podcasts going forward is really scary to the mainstream media.

**Newman:** There is no question about it and they're now trying to get into that realm. You see a bunch of these hacks from CNN and MSNBC. They're starting podcasts, but nobody's listening to them, right. People, frankly, are sick of those self styled gatekeepers and to your point about these little sound bites, you know, they take a little excerpt of a 2 hour speech from Donald Trump and totally out of context, and they say, see, we told you he was a racist. And so you still have, you know, 10, maybe 15 to 20% of the American population that believes that stuff. But what you're seeing is that is increasingly a fringe minority. And people now are going to other sources. People are going to the Joe Rogan's and the places where they can hear this guy explain his views for real without the interruptions, without the gotcha stuff and this really is a total reshaping of the media landscape. And I saw that this was coming when I was in journalism school 15 years ago. My professors were still living again in the last century. But we are in a new era now and they're going to try to regain control. You're going to see more and more of these fake newscasters becoming podcasters and trying to appeal to the younger people. But I really think that ship has sailed. I think they have lost their credibility beyond the point where it can be repaired and the polls bear this out. The overwhelming majority of Americans now regard the mainstream media as, in the words of the pollsters, enemies of the people. That's the overwhelming majority of Americans think that. I don't quite like that terminology. It reminds me a bit of, you know, the Soviet Union. But that speaks to where the American people are at with the fake news. They're sick of the lies. They're sick of the manipulation and we're never going back to the era that we had before. No matter how much they censor the Internet, no matter how much Google tries to rig the algorithms. They're not going to be able to put this back together.
